Dear President Kouchi, Speaker Saiki, and Members of the Legislature:

This is in response to Senate Concurrent Resolution No. 46, Senate Draft 1 (2022) requesting the Department of Hawaiian Home Lands to conduct a feasibility study on the creation of an enforcement division for the Department of Hawaiian Home Lands. DHHL testified in support of the resolution and since the resolution's adoption, several actions reflect the intention to pursue the establishment of a compliance and enforcement program rather than conduct a feasibility study.

#### Act 278 (2022)

Act 278 (2022) establishing a Department of Law Enforcement to consolidate and administer criminal law enforcement and investigations functions of the State is signed into law on July 8, 2022. The Act specifically requires the Director of Law Enforcement to administer public safety programs and formulate and implement state goals and objectives for state law enforcement programs and homeland security, including the deployment of adequate resources and coordination with county police departments to protect the health and safety of homestead communities on Hawaiian home lands. The Act also clearly expressed the Legislature's intent in noting the following: "The legislature does not intend to impair or diminish the longstanding authority and responsibility of county police departments to enforce the laws, along with state law enforcement, on state lands within their respective counties. County police departments will continue to have full law enforcement authority and responsibility, and in particular will continue to have full law enforcement authority and facilities." Enactment of this law with specific references to Hawaiian home lands was envisioned as a first step toward ensuring adequate law enforcement response to illegal activity on Hawaiian Home Lands.

### Hawaiian Home Commission Approves A Legislative Proposal Establishing a Compliance and Enforcement Program

The Hawaiian Homes Commission on September 19, 2022, approved legislative proposals to be recommended for inclusion in the Administration's legislative package for the 2023 Regular Session. One of the proposals would establish a compliance and enforcement program within the Department to investigate complaints, conduct investigations, and cooperate with enforcement authorities to ensure compliance with state law, including the Hawaiian Homes Commission Act, 1920, as amended, and the rules adopted thereunder, as well as all other state laws and rules and county ordinances on Hawaiian Home Lands. This action evidences the Commission's decision to introduce a measure that would move this issue forward for consideration by the legislature. The most updated version of this proposal is included in this response.

#### **DHHL General Plan Update 2022**

The Hawaiian Homes Commission on November 21, 2022 adopted the DHHL General Plan Update 2022 to provide comprehensive direction and guidance to the Department of Hawaiian Home Lands. The updated General Plan includes a section detailing the Land Use Planning Goals, Policies, and Metrics for 2040 and Goal LU-4 is to responsibly steward and manage Hawaiian home lands not planned for development within the Island Plans in a manner that is culturally grounded, environmentally sound, and maintains opportunities for future uses. Policy LU-4E within Goal LU-4 is to obtain funding to hire staff and establish and enforcement and compliance division to better manage possible unauthorized criminal, administrative, and civil matters on Hawaiian Home Lands. The metrics for this policy is that funding is requested/provided, the enforcement branch is established, and staff positions for enforcement are funded by the Legislature.

In light of the enactment of Act 278 (2022) and the decisions of the Hawaiian Homes Commission, DHHL believed it was more prudent to move toward implementation rather than utilize precious resources to conduct a feasibility study. The proposed legislation included with this response is submitted for the Legislature's consideration.

# A BILL FOR AN ACT

RELATING TO COMPLIANCE ON HAWAIIAN HOME LANDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that illegal activity
2	occurring on Hawaiian home lands threatens the health and safety
3	of the community. The purpose of this Act is to establish a
4	compliance and enforcement program within the department of
5	Hawaiian home lands to investigate complaints, conduct

§ -4 Rules. The department of Hawaiian home lands may promulgate rules and regulations, pursuant to chapter 91, necessary for administration of this chapter." SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$500,000 or so much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal year 2024-2025 for the compliance and enforcement program on Hawaiian home lands.

#### JUSTIFICATION SHEET

DEPARTMENT: Hawaiian Home Lands

TITLE: A BILL FOR AN ACT RELATING TO COMPLIANCE ON HAWAIIAN HOME LANDS.

- PURPOSE: To establish a compliance and enforcement program within the Department of Hawaiian Home Lands to investigate complaints, conduct investigations, and cooperate with enforcement authorities to ensure compliance with the Hawaiian Homes Commission Act, 1920, as amended, and rules adopted thereunder as well as all other state laws and rules, and county ordinances on Hawaiian home lands.
- MEANS: Add a new chapter to the Hawaii Revised Statutes.
- JUSTIFICATION: Criminal activity that is threatening the health and safety of the community must be addressed. The establishment of a compliance program within the Department of Hawaiian Home Lands will help to ensure responsive action is taken to address the noted concerns.
