# REPORT ON EXPENDITURE FROM THE MAJOR DISASTER FUND

Pursuant to the provisions of HRS 127A-16 Report to Thirty-Second Legislature Regular Session of 2023



Prepared pursuant to Hawai'i Revised Statutes §127A-16 by Hawai'i Emergency Management Agency State of Hawai'i

February 2023

Hawai'i Revised Statutes §127A-16 directs the Administrator of the Hawai'i Emergency Management Agency (HI-EMA) to report to the Legislature within 60 days of any allotment by the Governor or the expenditure of any fund moneys from the Major Disaster Fund (MDF). The report is to cover the purpose of the allotment/expenditure.

Governor David Y. Ige on Dec. 2, 2022, approved the release of \$4.5 million in general funds in State Fiscal Year 2023 for the MDF (see Appendix A). The release of funds was occasioned by the need to cover expenditures to support emergency measures resulting from the Mauna Loa volcanic eruption that began on Nov, 27, 2022.

Subsequently, Governor Josh Green, M.D., on Dec. 16, 2022 issued an emergency proclamation related to medical transport aircraft and crews, stemming from the crash of a Hawai'i Life Flight aircraft on route from Maui to Hawai'i island. That proclamation had been extended several times and remained in effect as of Feb. 1, 2023.

Spending from the MDF has been used to cover expenses related to both the Mauna Loa and Medical Transport Aircraft emergencies.

As of January 31, 2023, the following expenditures from the MDF for the specified incidents had been either recorded or estimated; some of the totals are not final and subject to adjustment when final invoices are received:
