## **SECOND REPORT ON THE STATE'S EFFORTS TO ADDRESS THE COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN**

Requested by House Resolution No. 83, H.D. 1  
Regular Session of 2021

Submitted to the Thirty-Second State Legislature  
Regular Session of 2023

### **I. Introduction**

House Resolution No. 83, H.D. 1 (2021) requested that the Department of the Attorney General (Department) submit an initial report and a second report to the Legislature. On December 1, 2021, the Department submitted its initial report, which assessed the State's efforts to address the commercial exploitation of children and provided plans and recommendations, including prevention strategies, victim assistance programs, law enforcement efforts, data collection, and public outreach and education programs. This is the Department's second report regarding its efforts to combat human trafficking. Because the landscape is largely unchanged since the initial report, the Department is providing a brief update regarding the creation of a division within the Department that will be responsible for combatting human trafficking in the State.

### **II. Creation of the Special Prosecution and Investigation Division**

During the 2022 legislative session, the Legislature budgetarily created the Special Investigation and Prosecution Division (SIPD) of the Department. The SIPD consists of two sections: the Corruption, Fraud, and Economic Crimes Section and the Human Trafficking Abatement Section. The SIPD's mission is to vigorously investigate and prosecute public corruption and human trafficking cases.

The SIPD will be supervised by Supervising Deputy Attorney General David Van Acker, and will be composed of the following additional positions: five deputy attorneys general (three primarily dedicated to public corruption and two primarily dedicated to human trafficking); three forensic analysts; seven investigators (five primarily dedicated to public corruption and two primarily dedicated to human trafficking); human trafficking abatement coordinator; human services professional; two legal assistants; and two legal clerks. The Department is in the hiring process and the goal for the division is to achieve full staffing by the end of 2022.

### **III. The SIPD's Human Trafficking Abatement Section**

The SIPD's Human Trafficking Abatement Section employs personnel that specialize in human trafficking so they can collaboratively create and implement investigative strategies unique to human trafficking. Having dedicated and experienced personnel in staff positions should lead to greater statewide human trafficking prosecution. The Human Trafficking Abatement Section will have the capability to provide substantial investigative and prosecutorial outreach, support, and expertise to neighbor island law enforcement entities (*e.g.*, local police departments and prosecutor's offices). The Human Trafficking Abatement Section will strengthen the state's ability to protect victims and hold offenders accountable.

In November 2022, the Department hired Lindsey Amina as the Statewide Human Trafficking Abatement Coordinator. As the State's Human Trafficking Abatement Coordinator, Lindsey will develop a multifaceted action plan aimed at improving services and outcomes for victims and survivors, prevention efforts, policy development, and prosecutions. Lindsey will also develop a plan to provide increased support and assistance for victims of child sexual exploitation, which will include collaborating on law enforcement efforts among local, state, and federal agencies as well as promoting public awareness of the availability of resources and services for victims and their families.
