ACT 067

A BILL FOR AN ACT

RELATING TO FIREWORKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In accordance with section 9 of article VII of
2	the Hawaii State Constitution and sections 37-91 and 37-93,
3	Hawaii Revised Statutes, the legislature has determined that the
4	appropriations contained in H.B. No. 300, H.D. 1, S.D. 1,
5	C.D. 1, and this Act will cause the state general fund
6	expenditure ceiling for fiscal year 2023-2024 to be exceeded by
7	\$1,065,017,367 or 11.0 per cent. This current declaration takes
8	into account general fund appropriations authorized for fiscal
9	year 2023-2024 in H.B. No. 300, H.D. 1, S.D. 1, C.D. 1, and this
10	Act only. The reasons for exceeding the general fund
11	expenditure ceiling are that:
12	(1) The appropriation made in this Act is necessary to
13	serve the public interest; and
14	(2) The appropriation made in this Act meets the needs
15	addressed by this Act.
16	SECTION 2. The legislature finds that illegal use of
17	fireworks in Hawaii has caused brush fires, structural fires,
18	injuries, and even death despite the various local, state, and

1 federal laws governing the manufacture, transportation,
2 distribution, sale, and use of fireworks. These laws continue
3 to be violated at what appears to be an increasing rate. While
4 law enforcement efforts to control illegal fireworks in Hawaii
5 have had limited results, the legislature finds that a concerted
6 multi-jurisdictional approach is needed to address the illegal
7 fireworks problem in Hawaii.

8 The purpose of this Act is to establish an illegal 9 fireworks task force to plan, coordinate, and engage in law enforcement operations to interdict illegal fireworks; develop a 10 comprehensive strategic plan to stop the importation of illegal 11 12 fireworks and explosives into Hawaii; promote compliance with 13 the state fireworks control laws; and ensure the safety and 14 security of the airports, harbors, and other facilities and 15 institutions in the State against the discharge of illegal 16 fireworks and explosives.

SECTION 3. (a) There shall be established within the department of law enforcement for administrative purposes the illegal fireworks task force. The task force shall use the findings from the legislative reference bureau's 2019 report, "Blast from the Past: An Update to the Report of the Illegal

1 Fireworks Task Force to the Legislature for the Regular Session of 2011", as the basis for developing a comprehensive strategic 2 plan to stop the importation of illegal fireworks and explosives 3 into Hawaii; promote compliance with the state fireworks control 4 5 laws; and ensure the safety and security of the airports, harbors, and other facilities and institutions in the State 6 7 against the discharge of illegal fireworks and explosives. The director of law enforcement or the director's 8 (b) 9 designee shall be the chair of the task force. 10 The following individuals or their designees shall (c) serve as members of the task force: 11 12 (1)Attorney general; Deputy director of the harbors division of the 13 (2)14 department of transportation; Chief of police of each county police department; and 15 (3) Prosecuting attorney of each county. 16 (4)The chair shall invite representatives of the 17 (d) 18 following federal entities to serve as members of the task 19 force: United States Attorney's Office, District of Hawaii; 20 (1) 21 (2) United States Department of Homeland Security;

Federal Bureau of Alcohol, Tobacco, Firearms and 1 (3) 2 Explosives; 3 (4)Federal Bureau of Investigation; 4 (5) United States Coast Guard; United States Customs and Border Protection; and 5 (6) Office of Homeland Security Investigations of the 6 (7) 7 United States Department of Homeland Security. 8 The task force and their represented agencies may (e) 9 plan, coordinate, and engage in law enforcement operations to 10 interdict illegal fireworks and the task force shall develop a 11 comprehensive strategic plan to stop the importation of illegal 12 fireworks and explosives into Hawaii; promote compliance with 13 the state fireworks control laws; and ensure the safety and 14 security of the airports, harbors, and other facilities and 15 institutions in the State against the discharge of illegal 16 fireworks and explosives.

(f) The task force shall submit an interim report on the status of its comprehensive strategic plan, including findings, recommendations, and any proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2024. The task force shall submit a

final report of its comprehensive strategic plan, including 1 2 findings, recommendations, and any proposed legislation, to the 3 legislature no later than twenty days prior to the convening of the regular session of 2025. 4 SECTION 4. There is appropriated out of the general 5 6 revenues of the State of Hawaii the sum of \$1,250,000 or so much 7 thereof as may be necessary for fiscal year 2023-2024 to carry 8 out the purposes of this Act, including the hiring of necessary 9 administrative support staff for the task force, operation of 10 the task force, and reimbursement of funds to law enforcement 11 agencies for task-force-related law enforcement operations, 12 including law enforcement personnel, overtime and other salaryrelated payments, charges for fuel, equipment, and storage and 13 14 disposal of confiscated fireworks. 15 The sum appropriated shall be expended by the department of

16 law enforcement for the purposes of this Act.

SECTION 5. This Act shall take effect on July 1, 2023, andshall be repealed on June 30, 2025.
