## A BILL FOR AN ACT

RELATING TO VOTING MORE THAN ONCE DURING AN ELECTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that existing law prohibits voters from voting again after having already voted. 2 However, the law does not expressly address the possibility that 3 a person could cast a single vote in Hawai'i and an additional 4 vote in another state or territory of the United States. 5 6 The purpose of this Act is to clarify the law by expressly prohibiting voters from casting more than one vote during any 7 election, even if one of those votes is in a state or territory 8 9 of the United States other than Hawai'i. 10 SECTION 2. Section 19-3, Hawaii Revised Statutes, is 11 amended to read as follows: 12 "§19-3 Election frauds. The following persons shall be 13 deemed guilty of an election fraud: 14 (1) Every person who, directly or indirectly, personally

15 or through another, gives, procures, or lends, or
16 agrees or offers to give, procure, or lend, or who
17 endeavors to procure, any money or office or place of

employment or valuable consideration to or for any 1 elector, [or to or for any] person for an elector, [or 2 to or for any] person in order to induce any elector 3 to vote or refrain from voting, or to vote or refrain 4 from voting for any particular person or party, or who 5 does any such act on account of any person having 6 voted or refrained from voting for any particular 7 person at any election; 8 (2) Every person who advances or pays, or causes to be 9 paid, any money to, or to the use of, any other 10 person, with the intent that the money, or any part 11 12 thereof, shall be expended in bribery at any election, or for any purpose connected with or incidental to any 13 election; or who knowingly pays or causes to be paid 14 any money to any person in the discharge or repayment 15 of any money wholly or partly expended in bribery at 16 any election, or for any purpose connected with or 17 incidental to any election; 18 (3) Every elector who, before, during, or after any 19 election, directly or indirectly, personally or 20 through another, receives, agrees, or contracts for 21

any money, gift, loan, or valuable consideration,
 office, place, or employment for oneself or any other
 person for voting or agreeing to vote, or for
 refraining to vote or agreeing to refrain from voting,
 or for voting or refraining to vote for any particular
 person or party;

7 (4) Every person who, directly or indirectly, personally or through another, makes use of, or threatens to make 8 use of, any force, violence, or restraint; or inflicts 9 10 or threatens to inflict any injury, damage, or loss in any manner, or in any way practices intimidation upon 11 12 or against any person in order to induce or compel the person to vote or refrain from voting, or to vote or 13 refrain from voting for any particular person or 14 party, at any election, or on account of the person 15 having voted or refrained from voting, or voted or 16 refrained from voting for any particular person or 17 party; or who by abduction, distress, or any device or 18 contrivance impedes, prevents, or otherwise interferes 19 20 with the free exercise of the elective franchise;

1	(5)	Every person who, at any election, votes or attempts
2		to vote in the name of any other person, living or
3		dead, or in some fictitious name, or who[, having once
4		<del>voted,</del> ] votes or attempts to vote [again,] more than
5		once during any election, regardless of whether one of
6		the elections is in a state or territory of the United
7		States outside of Hawaii, or knowingly gives or
8		attempts to give more than one ballot for the same
9		office at one time of voting; provided that a person
10		does not commit an election fraud if the person votes
11		once in Hawaii's primary election and also votes in

4		knowingly publishes a false statement of the
5		withdrawal of any candidate at the election;
6	(7)	Every person who induces or procures any person to
7		withdraw from being a candidate at an election in
8	•	consideration of any payment or gift or valuable
9		consideration; or of any threat; and every candidate
10		who withdraws from being a candidate in pursuance of
11		such inducement or procurement;
12	(8)	Every public officer by law required to do or perform
13		any act or thing with reference to any of the

15		wilfully fails, neglects, or refuses to do or perform
16		the same, or who is guilty of any wilful violation of

18	(9)	Any person wilfully tampering or attempting to tamper
19		with, disarrange, deface, or impair in any manner
20		whatsoever, or destroy, any voting machine while the
