## STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 153

Honorable Members Thirty-Second Legislature State of Hawai'i

Pursuant to Section 16 of Article III of the Constitution of the State of Hawai'i, I am returning herewith, without my approval, House Bill No. 153, entitled "A Bill for an Act Relating to State Water Code Penalties."

The purpose of this bill is to establish minimum and maximum penalties of \$50 and \$60,000 repectively for each day that a violation of the State Water Code, chapter 174C, Hawaii Revised Statutes, exists or continues.


This bill is objectionable because, while we understand and respect the need to hold violators of the State Water Code accountable, there are concerns that the significant increase of the maximum fine from \$5,000 a day to \$60,000 a day is not sufficiently justified. Several state agencies pump water to their housing developments, and there are indications that daily over-pumping from wells occurs throughout the State. This bill could have an adverse impact on new housing developments, because this is one of the first places county boards of water supply may look when there is a need to cut water usage.

For the foregoing reasons, I am returning House Bill No.153 without my approval.

# A BILL FOR AN ACT

RELATING TO STATE WATER CODE PENALTIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that in 1987, the state water code was adopted to protect the precious water resources of the State. To better enable the department of land and natural resources and commission on water resource management to carry out that mission, the legislature further finds that the water code's penalties and fines must be amended and increased to serve as an effective deterrence to violators.

8 The purpose of this Act is to ensure that all violators of 9 the state water code are held accountable for their violations 10 by creating a minimum penalty of \$50 and a maximum penalty of 11 \$60,000 for every violation.

SECTION 2. Section 174C-15, Hawaii Revised Statutes, is amended to read as follows:

14 "\$174C-15 Penalties and common law remedies. (a) The
15 commission may enforce its rules and orders adopted pursuant to
16 this chapter by suit for injunction or for damages or both.

1 of the violation and considering the history of such violations, 2 degree of culpability, and other matters as justice may require. 3 [<del>(c)</del>] (d) No provision of this chapter shall bar the right 4 of any injured person to seek other legal or equitable relief 5 against a violator of this chapter. 6 [(d)] (e) Except as otherwise provided by law, the commission or its authorized representative by proper delegation 7 8 [may] shall set, charge, and collect administrative fines; [or] 9 may bring legal action to recover administrative fees and costs 10 as documented by receipts or affidavit, including [attorneys] 11 attorney's fees and costs; [or] and may bring legal action to recover administrative fines, fees, and costs, including 12 13 [attorneys'] attorney's fees and costs, or payment for damages 14 resulting from a violation of this chapter or any rule adopted 15 pursuant to this chapter."
