An agreement has been reached concerning the University of Hawai'i Professional Assembly's collective bargaining for Unit 7 (University of Hawai'i Faculty) for the re-opener for Employer-Union Trust Fund (EUTF) contribution amounts. Notice of ratification of the agreement was received on April 14, 2023. In accordance with Section 89-11, cost items must be submitted to the Legislature for appropriation. The following summary of the included and excluded requirements of the settlement for the current fiscal biennium is being transmitted to the Legislature for authorization:


