RELATING TO METHADONE TREATMENT PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 329-40, Hawaii Revised Statutes, is	
2	amended by	y amending subsection (b) to read as follows:	
3	"(b)	Registration of a methadone treatment program	
4	requires that:		
5	(1)	The methadone treatment program obtain a controlled	
6		substance registration from the State of Hawaii and	
7		the Drug Enforcement Administration;	
8	(2)	The medical director of a methadone treatment program	
9		obtain a controlled substance registration from the	
10		State of Hawaii and the Drug Enforcement	
11		Administration at the location of the program;	
12	(3)	Admission to a methadone treatment program be limited	
13		to the narcotic-dependent persons as defined in this	
14		chapter;	
15	(4)	Unless otherwise stated in this chapter, admission to	
16		a methadone treatment program be in accordance with

3	(5)	All medical orders including initial medication
4		orders, all subsequent medication order changes, all

9	(6)	Only the medical director or other designated program
10		physician authorize a patient's admission for

than two weeks unless authorized by the state authority.

The term "methadone treatment program" as used in this 3 4 section means an organization or a person (including a private 5 physician) that administers or dispenses methadone to a 6 narcotic-dependent person for maintenance or detoxification 7 treatment and who provides the medical and rehabilitative 8 services required by Title 21 Code of Federal Regulations Part 9 291 or Title 42 Code of Federal Regulations Part 8 and is 10 approved to do so by the State and by the United States 11 Substance Abuse and Mental Health Services Administration, and 12 who holds a controlled substance registration as required by 13 this chapter and the United States Drug Enforcement 14 Administration to use methadone for the treatment of narcoticdependent persons. 15

16 The term "narcotic-dependent person" as used in this 17 section means an individual who physiologically needs heroin or 18 a morphine-like drug to prevent the onset of signs of 19 withdrawal.

20 The term "state authority" as used in this section means
21 the agency within the State [which] that exercises the

JUSTIFICATION SHEET

DEPARTMENT: Public Safety.

- TITLE: A BILL FOR AN ACT RELATING TO METHADONE TREATMENT PROGRAMS.
- PURPOSE: To enable the medical director of a methadone treatment program to dispense to a patient the maximum days of supply of takehome doses allowed under federal law.
- MEANS: Amend section 329-40(b), Hawaii Revised Statutes (HRS).
- JUSTIFICATION: This bill seeks to ensure that the limits for dispensing take-home doses of methadone in Hawaii law are consistent with federal law and that patients have access to the maximum number of doses needed for their treatment. This bill will also serve to minimize patient and staff inconvenience and the waste of important healthcare resources. The bill would reduce barriers to effective treatment and reduce the unnecessary waste of healthcare resources.

Impact on the public: Increased positive public health outcomes for the community.

Impact on the department and other agencies: Increased needed assistance to the Department of Health and private methadone treatment programs.
