# A BILL FOR AN ACT

RELATING TO MEAT DONATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a need for
- 2 an increased protein donation capacity to feed local under-
- 3 resourced populations. Existing law specifically prohibits the
- 4 inclusion of meat as a donation; however, wild game can be a
- 5 significant source of protein. The inclusion of wild game as a
- 6 donation-eligible food resource creates a beneficial outlet for
- 7 food-safe meat harvested from invasive species.
- 8 The legislature also finds that Wisconsin, Michigan, and
- 9 Utah offer meat donation programs that can serve as models that
- 10 Hawaii can assess to develop tools for long-term, sustainable,
- 11 management programs for invasive species. For example, Utah
- 12 amended its Good Samaritan law to enable the harvest of white
- 13 tail deer meat for donation to charities and provided an
- 14 exception to antemortem inspection if certain requirements and
- 15 conditions are met.

1	Accordingly, the purpose of this Act is to amend the		
2	condition	s for donations to allow provision of wild meat to	
3	under-resourced communities, including the homeless.		
4	SECT	ION 2. Section 145D-2, Hawaii Revised Statutes, is	
5	amended by amending subsections (d) and (e) to read as follows:		
6	"(d)	The exceptions to liability specified in subsection	
7	(a) shall	include:	
8	(1)	The donation of perishable or nonperishable food that	
9		has exceeded the labeled shelf life date recommended	
10		by the manufacturer; [and]	
11	(2)	The donation of farm produce; provided that the good-	
12		faith donor or distributor reasonably believes that	
13		the food is fit for human consumption[-]; and	
14	(3)	The donation of livestock or wild game meat; provided	
15		that the good-faith donor harvested the meat in a	
16		food-safe manner and processed the meat in accordance	
17		with federal law and the distributor reasonably	
18		believes that the food is fit for human consumption.	
19	(e)	For the purposes of this section:	
20	"Don	or" means any individual, food vendor, food	
21	manufactu	rer, food distributor, grocery or convenience store,

- 1 charitable or nonprofit organization, butcher, meat processor,
- 2 or government agency that donates food to needy persons where
- 3 the food in question has been prepared and packaged in a
- 4 facility meeting all relevant food safety guidelines,
- 5 certifications, and requirements and has passed all food safety
- 6 inspections.
- 7 "Farm produce" means all agricultural, horticultural, and
- 8 vegetable produce of the soil, but does not include poultry,
- 9 poultry products, livestock and livestock products, aquaculture
- 10 and aquaculture products, and timber or timber products."
- 11 SECTION 3. (a) There is established within the department
- 12 of agriculture for administrative purposes a meat processing
- 13 task force to develop and implement a plan to expand the meat
- 14 processing capacity in the State to allow for meat from axis
- 15 deer and other wild game to be processed for distribution by
- 16 nonprofit food distribution services. The meat processing task
- 17 force shall be composed of the following members:
- 18 (1) The chairperson of the board of agriculture, or the
- chairperson's designee;
- 20 (2) One member from the department of health, selected by
- 21 the director of health;

1	(3)	One member from the department of business, economic
2		development, and tourism, selected by the director of
3		business, economic development, and tourism;
4	(4)	The administrator of the division of forestry and
5		wildlife of the department of land and natural
6		resources, or the administrator's designee;
7	(5)	The chairperson of the board of land and natural
8		resources, or the chairperson's designee;
9	(6)	One member from the United States Environmental
10		Protection Agency who shall be invited by the
11		chairperson of the task force;
12	(7)	Four members, one each to be appointed by the
13		respective mayors of the city and county of Honolulu,
14		and the counties of Hawaii, Kauai, and Maui; and
15	(8)	Four members to be jointly selected and invited to
16		participate by the president of the senate and the
17		speaker of the house of representatives, two of whom
18		shall be selected from an environmental nonprofit
19		organization, and two of whom shall be selected from
20		an agricultural or ranching association.

- 1 (b) The members of the task force shall choose a
- 2 chairperson from among themselves.
- 3 (c) Task force members may recommend members with
- 4 appropriate specialized expertise to be added to the task force,
- 5 subject to the approval of the chairperson of the task force.
- 6 (d) The task force shall create a master plan to expand
- 7 the meat processing capacity in the State to allow for meat from
- 8 axis deer and other wild game to be processed for distribution
- 9 by nonprofit food distribution services.
- 10 (e) The task force shall submit a report of its findings
- 11 and recommendations, including any proposed legislation, to the
- 12 legislature no later than twenty days prior to the convening of
- 13 the regular session of 2024.
- 14 SECTION 4. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2023-2024 and
- 17 the same sum or so much thereof as may be necessary for fiscal
- 18 year 2024-2025 for the meat processing task force to develop and
- 19 implement a masterplan to expand meat processing capacity in the
- 20 State to allow for wild game to be distributed by nonprofit food
- 21 distribution services.

- 1 The sums appropriated shall be expended by the department
- 2 of agriculture for the purposes of this Act.
- 3 SECTION 5. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 6. This Act shall take effect on June 30, 3000.
