A BILL FOR AN ACT

RELATING TO DIGITAL EQUITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that digital equity 2 across the State and in every community is essential to the well-being and economic realities of the State's residents. 3 The 4 need for digital equity is significant, highlighted by the 5 devastating impacts of the recent coronavirus disease 2019 6 pandemic. The lack of digital equity has had a tremendously negative effect in many areas, but particularly socio-7 8 economically disadvantaged communities.

9 The legislature further finds that digital equity has meant 10 the difference between an employee being able to work remotely 11 or possibly facing unemployment. Additionally, digital literacy 12 and broadband access are critical tools for those seeking to 13 access social services such as unemployment claims, Supplemental 14 Nutrition Assistance Program (SNAP) benefits, vital records, and 15 other essential government, educational, and medical services. 16 The legislature further finds that digital equity in the 17 State would enhance Hawaii's overall economic development,

education, health care, and emergency services. Making grants
 available to achieve digital equity for disadvantaged
 populations would move the State toward universal access to
 broadband services.

5 The legislature strongly supports efforts to improve
6 digital equity for residents, consumers, and businesses across
7 the State.

8 The purpose of this Act is to identify and address any 9 remaining obstacles to digital equity in all areas of the State 10 by establishing the digital equity grant program to award grants 11 and create an environment in which all individuals and 12 communities in the State have the information technology 13 capacity needed for full participation in society, democracy, 14 and the economy.

15 SECTION 2. The Hawaii Revised Statutes is amended by 16 adding a new chapter to title 13 to be appropriately designated 17 and to read as follows:

1 Individuals who primarily reside in a rural area; and (8) 2 (9) Homeless or unsheltered individuals. 3 "Department" means the department of business, economic development, and tourism. 4 5 "Digital equity" means a condition in which all individuals 6 and communities have the information technology capacity needed 7 for full participation in society, democracy, and the economy. "Digital equity services" means a service that increases 8 9 digital literacy and broadband access in covered populations. 10 "Office" means the Hawaii broadband and digital equity office. 11 12 "Program" means the digital equity grant program 13 established by this chapter. 14 "Project" means a proposed digital equity project set forth 15 in an application for grant funding authorized by this chapter. 16 "Project area" means an area that is proposed to be covered 17 in an application for grant funding authorized by this chapter. 18 -2 Digital equity grant program; establishment. There S 19 is established a digital equity grant program, which shall be 20 placed within the office for administrative purposes. The

office shall receive and review grant applications and may award
 grants for eligible projects pursuant to the program.

3 § -3 Eligible projects. To be eligible for a grant, the
4 area to be served by the project shall include covered
5 populations on the date the application is submitted. Projects
6 that include the deployment of broadband infrastructure shall be
7 ineligible for a grant.

§ -4 Applicant preference. In making awards, the office
9 shall give preference to applicants that are non-governmental
10 entities with demonstrated experience in providing digital
11 equity services to covered populations. Governmental agencies
12 may apply and shall be evaluated on a case-by-case basis.

13 § -5 Applications. (a) The office shall establish an 14 annual time period during which it shall accept applications for 15 funding under the program. The time period for submission shall 16 be no less than sixty days and no more than ninety days.

17 (b) The form of the application shall be as prescribed by18 the office and shall include:

19 (1) Evidence demonstrating the applicant's experience and
20 ability to plan, organize, staff, and deliver digital

18		facilitating the deployment of projects to covered

 (2) Not impose any financial penalty or liquidated damages
 provisions or provisions that are not reasonably
 related to the deployment of programs in the State in
 accordance with this chapter."

7 SECTION 3. Within six months after the effective date of 8 this Act, the department of business, economic development, and 9 tourism shall adopt rules pursuant to chapter 91 and 10 -8, Hawaii Revised Statutes, to implement the digital section 11 equity grant program; provided that any rules adopted pursuant 12 to this section shall include rules regarding the submission, 13 review, and approval of applications; administration of the 14 projects funded; and grant agreements memorializing the award of 15 funds.

SECTION 4. There is appropriated out of the general revenues of the State of Hawaii the sum of \$5,000,000 or so much thereof as may be necessary for fiscal year 2023-2024 and the same sum or so much thereof as may be necessary for fiscal year 2024-2025 for the digital equity grant program established by this Act.

The sums appropriated shall be expended by the department
 of business, economic development, and tourism for the purposes
 of this Act.

4 SECTION 5. This Act shall take effect on June 30, 3000.
