## A BILL FOR AN ACT

RELATING TO THE WORKS OF ART SPECIAL FUND.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Section 103-8.5, Hawaii Revised Statutes, is  
2 amended as follows:

3 1. By amending subsection (a) to read:

4 "(a) There is created a works of art special fund, into  
5 which shall be transferred [~~one~~] 0.5 per cent of all state fund  
6 appropriations for capital improvements designated for the  
7 construction cost element; provided that this transfer shall  
8 apply only to capital improvement appropriations that are  
9 designated for the construction [~~or renovation~~] of new state  
10 buildings[~~-~~], properties, or facilities. The [~~one~~] 0.5 per cent  
11 transfer requirement shall not apply to appropriations from the  
12 passenger facility charge special fund established by section  
13 261-5.5 and the rental motor vehicle customer facility charge  
14 special fund established under section 261-5.6."

15 2. By amending subsection (c) to read:

16 "(c) The [~~one~~] 0.5 per cent amount, which is included in  
17 all capital improvement appropriations[~~-~~] designated for the



1 construction of new state buildings, properties, or facilities,  
2 shall be calculated at the time the appropriation bills are  
3 signed into law. The moneys shall be transferred into the works  
4 of art special fund upon availability of moneys from the  
5 appropriations. Each agency receiving capital improvement  
6 appropriations shall calculate the [~~one~~] 0.5 per cent amount and  
7 transfer the moneys into the works of art special fund."

8 3. By amending subsections (e) and (f) to read:

9 "(e) The comptroller shall:

10 (1) Provide each agency receiving capital improvement  
11 appropriations with information regarding items that  
12 shall be included and excluded from the [~~one~~] 0.5 per  
13 cent amount;

14 (2) Ensure that each agency calculates its [~~one~~] 0.5 per  
15 cent amount correctly; and

16 (3) Ensure that each agency transfers the correct amount  
17 to the works of art special fund in a timely manner.

18 (f) The comptroller and the executive director shall track  
19 amounts due from each agency under the [~~one~~] 0.5 per cent  
20 requirement as provided in this section."



1 SECTION 2. Statutory material to be repealed is bracketed  
2 and stricken. New statutory material is underscored.

3 SECTION 3. This Act shall take effect upon its approval.

**Report Title:**

Works of Art Special Fund; Capital Improvement Appropriations

**Description:**

Specifies that 0.5 per cent, rather than one per cent, of state fund appropriations for capital improvements shall be transferred into the Works of Art Special Fund. Limits the 0.5 per cent amount to appropriations designated for the construction of new state buildings, properties, or facilities.
