## A BILL FOR AN ACT

RELATING TO NATIVE HAWAIIAN AFFAIRS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to appropriate
- 2 moneys to the department of business, economic development, and
- 3 tourism and the department of land and natural resources to
- 4 improve Native Hawaiian communities and culture through various
- 5 assistance services, including but not limited to services that
- 6 offer Native Hawaiian historic preservation, business training,
- 7 entrepreneurship, and mentoring.
- **8** SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2023-2024 and
- 11 the same sum or so much thereof as may be necessary for fiscal
- 12 year 2024-2025 for the purpose of improving Native Hawaiian
- 13 communities and culture by providing a virtual marketplace that
- 14 supports local artisans and businesses to adapt to e-commerce.
- 15 The sums appropriated shall be expended by the department
- 16 of business, economic development, ad tourism for the purposes
- 17 of this Act.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2023-2024 and
- 4 the same sum or so much thereof as may be necessary for fiscal
- 5 year 2024-2025 for the purpose of improving Native Hawaiian
- $oldsymbol{6}$  communities and culture by providing a physical co-working space
- 7 and an innovation, entrepreneur, and resource center that
- 8 provides workshops, counseling, loan assistance, and broadband
- 9 access.
- 10 The sums appropriated shall be expended by the department
- 11 of business, economic development, and tourism for the purposes
- 12 of this Act.
- 13 SECTION 4. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2023-2024 and
- 16 the same sum or so much thereof as may be necessary for fiscal
- 17 year 2024-2025 for the repatriation and reburials of Native
- 18 Hawaiians nationally and internationally.
- 19 The sums appropriated shall be expended by the department
- 20 of land and natural resources for the purposes of this Act.

1 SECTION 5. This Act shall take effect on June 30, 3000.
