### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 11 | (b) Beginning January 1, 2024, every rental kayak provided     |
| 12 | or offered to the public shall have the identification number  |
| 13 | affixed to the rental kayak.                                   |
| 14 | (c) The department shall establish reasonable fees for the     |
| 15 | initial annual registration and annual renewal registration in |
| 16 | accordance with rules adopted pursuant to chapter 91.          |
