A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is a matter of
- 2 statewide concern that the president of the University of Hawaii
- 3 serves simultaneously as the chief procurement officer for the
- 4 University of Hawaii system. The president of the system
- 5 simultaneously serving as the chief procurement officer leads to
- 6 inevitable conflicts of interest.
- 7 The legislature further finds that across the United
- 8 States, the vast majority of public higher education
- 9 institutions, including the California State University System,
- 10 University of Massachusetts System, and University of Oregon
- 11 System, differentiate between institutional leadership and
- 12 purchasing when assigning the authority over procurement. While
- 13 the chief procurement officer for the Colorado State University
- 14 System possesses authority over state purchasing and procurement
- 15 as well as direct oversight over Colorado's institutions of
- 16 higher learning, there were no instances in institutions across

- 1 the country in which a university president is concurrently
- 2 named as chief procurement officer.
- 3 Accordingly, the purpose of this Act is to designate the
- 4 vice president for budget and finance and chief financial
- 5 officer as the chief procurement officer for the University of
- 6 Hawaii.
- 7 SECTION 2. Section 103D-203, Hawaii Revised Statutes, is
- 8 amended by amending subsection (a) to read as follows:
- 9 "(a) The chief procurement officer for each of the
- 10 following state entities shall be:
- 11 (1) The judiciary--the administrative director of the
- 12 courts;
- 13 (2) The senate--the president of the senate;
- 14 (3) The house of representatives -- the speaker of the house
- of representatives;
- 16 (4) The office of Hawaiian affairs--the chairperson of the
- 17 board;
- 18 (5) The University of Hawaii--[the-president of the
- 19 University of Hawaii; the vice president for budget
- and finance and chief financial officer;

13	and stricken. New statutory material is underscored.	
14	SECTION 4. This Act shall take effect upon its approval;	
15	provided that the amendments made to section 103D-203(a), Hawaii	
16	Revised Statutes, by section 2 of this Act shall not be repealed	
17	when that section is reenacted on June 30, 2024, pursuant to	
18	section 1	6 of Act 8, Special Session Laws of Hawaii 2021.
