A BILL FOR AN ACT

RELATING TO THE HAWAII THEATRE CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii Theatre
- 2 Center is the second largest proscenium performance facility in
- 3 the State and is the only remaining theatre of its type in
- 4 Hawaii. Established in 1922, the Hawaii Theatre Center has
- 5 operated as a 501(c)(3) nonprofit organization since 1984.
- 6 The legislature also finds that the Hawaii Theatre Center,
- 7 listed on both the Hawaii and national registers of historic
- 8 places, has been recognized nationally for its historic,
- 9 architectural, and community significance. In 2005, the Hawaii
- 10 Theatre Center was recognized as the 2005 Outstanding Historic
- 11 Theatre in America by the League of Historic American Theaters.
- 12 The Hawaii Theatre Center was awarded the 2006 National
- 13 Preservation Honor Award by the National Trust for Historic
- 14 Preservation.
- 15 The legislature recognizes that, throughout its many years
- 16 of service, the Hawaii Theatre Center has established critical
- 17 areas of expertise and provides significant intangible benefit

- 1 to Hawaii and its people by offering the community an historic
- 2 performing arts facility with exceptional technical capacity.
- 3 The legislature further finds that the Hawaii Theatre
- 4 Center has served the community for nearly a century as Hawaii's
- 5 theatre without the benefit of regular, predictable support from
- 6 state sources to assist in the preservation of its irreplaceable
- 7 facility, staff its programs, and plan and present its events
- 8 and educational programs.
- **9** The purpose of this Act is to:
- 10 (1) Officially designate the Hawaii Theatre Center as the
- 11 Hawaii State Theatre;
- 12 (2) Implement this status through an annual appropriation
- from the general revenues of the State; and
- 14 (3) Appropriate funds to support the work of the Hawaii
- 15 Theatre Center.
- 16 SECTION 2. Chapter 6E, Hawaii Revised Statutes, is amended
- 17 by adding a new section to part II to be appropriately
- 18 designated and to read as follows:
- 19 "§6E- Hawaii Theatre Center. (a) The official
- 20 designation of the Hawaii Theatre Center shall be the Hawaii
- 21 State Theatre. This status shall be implemented by the

- 1 department of land and natural resources historic preservation
- 2 program through an annual appropriation from the general
- 3 revenues of the State.
- 4 (b) This designation shall not impinge on the autonomy of
- 5 the Hawaii Theatre Center, nor imply state control over its
- 6 programs or policies, except as specifically provided in this
- 7 section.
- 8 (c) Notwithstanding any provision to the contrary in
- 9 chapter 42F, the qualifying standards and conditions related to
- 10 the receipt of funds contained in chapter 42F shall not apply to
- 11 funds received by the Hawaii State Theatre; provided that if the
- 12 theatre in turn contracts with a recipient or provider, then the
- 13 qualifying standards, conditions, and other provisions of
- 14 chapter 42F shall apply to the recipient or provider and the
- 15 contract.
- 16 (d) The comptroller and the auditor shall have the
- 17 authority to examine the Hawaii Theatre Center's use of state
- 18 funds and shall report any findings to the legislature.
- 19 (e) The chair of the Hawaii Theatre Center board of
- 20 directors shall submit an annual report to the legislature no
- 21 later than twenty days prior to the convening of each regular



- 1 session. The annual report shall include, at minimum, an
- 2 explanation of any facility maintenance and other functions
- 3 accomplished by state fund expenditures in the previous fiscal
- 4 year."
- 5 SECTION 3. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2023-2024 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2024-2025 for to support the work of the Hawaii Theatre
- 10 Center.
- 11 The sums appropriated shall be expended by the department
- 12 of land and natural resources for the purposes of this Act.
- 13 SECTION 4. New statutory material is underscored.
- 14 SECTION 5. This Act shall take effect on July 1, 2023.
