A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Alzheimer's disease
- 2 is a large and growing epidemic that has a huge impact in
- 3 Hawaii. More than six million Americans are currently living
- 4 with Alzheimer's disease, a figure expected to reach 12.7
- 5 million in 2050. In 2019, Alzheimer's disease was the sixth
- 6 leading cause of death in the United States, with deaths from
- 7 the disease having risen by one hundred forty-five per cent
- 8 between 2000 and 2019.
- 9 The legislature further finds that the impact of
- 10 Alzheimer's disease in Hawaii is projected to rise. According
- 11 to data from the Alzheimer's Association, twenty-nine thousand
- 12 people aged sixty-five and older are living with Alzheimer's
- 13 disease, 6.7 per cent of people aged forty-five and older have
- 14 subjective cognitive decline, and fifty-two thousand family
- 15 caregivers bear the burden of caring for someone having
- 16 Alzheimer's disease in Hawaii. In 2020, family members and
- 17 friends of individuals living with Alzheimer's disease and other

- 1 forms of dementia in the State provided eighty-three million
- 2 hours of care at an economic value of nearly \$1,700,000,000.
- 3 The legislature additionally finds that one-third of
- 4 recipients of home health care and adult day care have
- 5 Alzheimer's disease. The average per-person medicaid spending
- 6 for seniors with Alzheimer's disease and other forms of dementia
- 7 is twenty-three times greater than the average per-person
- 8 medicaid spending across all seniors without dementia. In
- 9 total, caring for people having Alzheimer's disease generated an
- 10 estimated medicaid cost of \$59,000,000,000 in 2021. Between
- 11 2020 and 2025, thirty states will see medicaid spending on
- 12 people having Alzheimer's disease increase by at least twenty
- 13 per cent, before adjusting for inflation. By 2050, medicaid
- 14 spending on those people having Alzheimer's disease will total
- 15 an estimated \$199,000,000,000, based on current dollars.
- 16 The purpose of this Act is to appropriate funds for the
- 17 executive office on aging to create an Alzheimer's disease and
- 18 related dementias public health campaign.
- 19 SECTION 2. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 21 thereof as may be necessary for fiscal year 2023-2024 for the

- 1 executive office on aging of the department of health to create
- 2 and implement an Alzheimer's disease and related dementias
- 3 public health campaign to educate the public on:
- 4 (1) The early signs of cognitive impairment;
- 5 (2) The value of early detection and diagnosis of
- 6 cognitive impairment; and
- 7 (3) The importance of discussing with health care
- 8 professionals any changes in memory and thinking.
- 9 The sum appropriated shall be expended by the executive
- 10 office on aging for the purposes of this Act.
- 11 SECTION 3. In accordance with section 9 of article VII of
- 12 the Hawaii State Constitution and sections 37-91 and 37-93,
- 13 Hawaii Revised Statutes, the legislature has determined that the
- 14 appropriations contained in H.B. No. 300, H.D. 1, S.D. 1,
- 15 C.D. 1, will cause the state general fund expenditure ceiling
- 16 for fiscal year 2023-2024 to be exceeded by \$1,063,767,367 or
- 17 10 per cent. In addition, the appropriations contained in this
- 18 Act will cause the general fund expenditure ceiling for fiscal
- 19 year 2023-2024 to be further exceeded by \$1,000,000 or 1 per
- 20 cent. The combined total amount of general fund appropriations
- 21 contained in only these two Acts will cause the state general

- 1 fund expenditure ceiling for fiscal year 2023-2024 to be
- $\mathbf{2}$ exceeded by \$1,064,767,367 or 11 per cent. The reasons for
- 3 exceeding the general fund expenditure ceiling are that:
- 4 (1) The appropriation made in this Act is necessary to serve the public interest; and
- 6 (2) The appropriation made in this Act meets the needs7 addressed by this Act.
- 8 SECTION 4. This Act shall take effect on July 1, 2023.
