### A BILL FOR AN ACT

RELATING TO EDUCATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that books and other 2 instructional materials are needed in alternate accessible 3 formats for use by elementary and secondary school students who 4 are unable to use print as their primary learning media. The 5 federal Individuals with Disabilities Education Improvement Act of 2004, P.L. 108-446, made important changes to the law, 6 7 including the establishment of the National Instructional 8 Materials Accessibility Standard and the National Instructional 9 Materials Access Center, which serves as a central repository 10 for files formatted in accordance with the National Instructional Materials Accessibility Standard and as a conduit 11 12 for the distribution of those files to schools.

13 The legislature further finds that existing state law
14 pertaining to instructional materials for exceptional children
15 directs publishers to meets requirements that are now out of
16 date and undesirable due to advances in technology. Thus, a
17 revision is necessary to harmonize existing state law with the

2	advancements that make more instructional materials available in		
3	appropriate accessible formats.		
4	Accordingly, the purpose of this Act is to:		
5	(1) Provide for the timely availability of accessible		
6	instructional materials and technology for eligible		
7	students; and		
8	(2) Assure that such materials are distributed to eligible		
9	students in accordance with the federal Individuals		
10	with Disabilities Education Act, as amended, and the		
11	federal Copyright Act of 1976, as amended.		
12	SECTION 2. Section 302A-442.5, Hawaii Revised Statutes, is		
13	amended to read as follows:		
14	"§302A-442.5 Instructional materials; exceptional		
15	children. (a) Whenever used in this section, unless a		
16	different meaning clearly appears from the context:		
17	"Accessible format" has the same meaning as in section		
18	121(d)(1) of the federal Copyright Act of 1976 (17 U.S.C.		
19	121(d)(1)), as amended.		
20	"Accessible instructional materials" means print		
21	instructional materials provided to eligible students in the



9	"Braille" means the system of reading and writing through

11	"Eligible student" means an elementary or secondary school

13	(1)	Is eligible for services under the federal Individuals	
14		with Disabilities Education Act, as amended;	
15	(2)	Is approved as an eligible person, as defined in	
16		section 121(d)(3) of the federal Copyright Act of 1976	
17		(17 U.S.C. 121(d)(3)), as amended; and	
18	(3)	Attends a department school, a private school under	
19		chapter 302C, a public charter school under chapter	
20		302D, or an approved alternative education program	
21		under section 302A-1132(a)(5).

2	center established pursuant to section 674(e) of the federal		
3	Individuals with Disabilities Education Act (20 U.S.C. 1474(e)),		
4	as amended.		
5	"National Instructional Materials Accessibility Standard"		
6	has the same meaning as in section 674(e)(3)(B) of the federal		
7	Individuals with Disabilities Education Act (20 U.S.C.		
8	1474(e)(3)(B)), as amended.		
9	"Print instructional materials" includes but is not limited		
10	to textbooks, articles, handouts, posters, bulletin boards,		
11	maps, charts, graphics, audio-visual presentations, digital		
12	instructional materials, and all other printed materials		
13	available to students in elementary and secondary classrooms.		
14	"Technology mediated instruction" means learning that is		
15	aided or entirely accomplished through the use of computer-based		
16	technology.		
17	(b) [ <del>All publishers of textbooks and instructional</del>		
18	materials sold to the State or any public school shall furnish		
19	computer diskettes for literary subjects in the American		
20	Standard Code for Information Interchange from which braille		
21	versions can be produced. Publishers shall also furnish

1	computer diskettes in American Standard Code for Information
2	Interchange for nonliterary subjects including natural sciences,
3	computer science, mathematics, and music when braille specialty
4	code translation software is available.] In accordance with
5	section 612(a)(23) of the federal Individuals with Disabilities
6	Education Act (20 U.S.C. 1412(a)(23)), as amended, the State
7	adopts the United States Secretary of Education's National
8	Instructional Materials Accessibility Standard as in effect on
9	the effective date of this Act and as may be subsequently
10	revised. The department shall coordinate with the National
11	Instructional Materials Access Center to obtain the benefits of
12	this service.
13	(c) [ <del>This section shall not apply to publishers of</del>
14	textbooks and instructional materials written in the Hawaiian
15	language.] The department, as part of any print instructional
16	materials adoption process, procurement contract, or other
17	practice or instrument used for purchase of print instructional
18	materials, including digital materials, shall:
19	(1) Obtain instructional materials from the publisher or
20	other source that are in, or can be rendered in, the

1		appropriate accessible format for the eligible student	
2	using the instructional material; or		
3	(2)	If the needed instructional materials cannot be	
4		obtained in the eligible student's appropriate	
5		accessible format, the department shall enter into a	
6		written contract with the publisher of the print	
7		instructional materials to require the publisher to	
8		prepare and, on or before delivery of the print	
9	instructional materials, provide to the National		
10	Instructional Materials Access Center electronic files		
11		containing the contents of the print instructional	
12		materials using the National Instructional Materials	
13		Accessibility Standard.	
14	(d)	The department shall obtain accessible instructional	
15	materials	for eligible students attending any department school	
16	and, to t	he maximum extent allowed, assist any private school	
17	under cha	pter 302C, public charter school under chapter 302D, or	
18	eligible	student enrolled in an approved alternative education	
19	program p	ursuant to section 302A-1132(a)(5), to obtain	
20	instructi	onal materials in accessible formats when the	
21	departmen	t receives a request from the school or program;

5	(e) Each eligible student shall receive accessible		
6	instruction materials without regard to whether the accessible		
7	instructional materials have been purchased in accordance with		
8	subsection (c). Eligible students shall receive accessible		
9	instructional materials at the same time the corresponding print		
10	instructional materials are provided to all other students in		
11	the classroom, including any assistive technology device and		
12	assistive technology service to be provided in advance and		
13	needed for the eligible student to use the accessible		
14	instructional materials.
