A BILL FOR AN ACT

RELATING TO RESIDENT TUITION AT THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that many of the State's high school graduates attend college outside of Hawaii. These students are often near the top of their high school class, and many of these students remain on the mainland or outside Hawaii following graduation from college. This contributes to Hawaii's "brain drain" and impacts Hawaii's economy.

7 The purpose of this Act is to encourage all Hawaii high 8 school graduates to stay in Hawaii, especially those who would 9 not otherwise qualify for resident tuition, by requiring the 10 university of Hawaii board of regents to allow all Hawaii high 11 school graduates to qualify for resident tuition.

12 SECTION 2. Section 304A-402, Hawaii Revised Statutes, is 13 amended to read as follows:

14 "[+]\$304A-402[+] Residence for tuition purposes; basic
15 rule. The board of regents shall adopt the necessary rules
16 defining residence for tuition purposes herein; provided that

1 the basic rule shall be that a student shall qualify for the 2 resident tuition fee only if the following criteria are met: 3 (1)(A) The adult student, or in the case of a minor 4 student, the student's parents or guardians, has 5 or have been a bona fide resident of this State 6 for at least twelve consecutive months next 7 preceding the student's first day of officially 8 scheduled instruction for any semester or term in 9 which the student is enrolling at the particular 10 college or campus; and 11 $\left[\frac{(2)}{(2)}\right]$ (B) The adult or minor student has not been 12 claimed as a dependent for tax purposes for at 13 least twelve months next preceding the student's 14 first day of officially scheduled instruction for 15 any semester or term in which the student is 16 enrolling at the particular college or campus by 17 the student's parents or guardians who are nonresidents of the State; provided that this 18 19 provision shall not apply in cases where the 20 parent claiming the student as a dependent is 21 entitled to do so under a child support order or
