### A BILL FOR AN ACT

RELATING TO ALBIZIA.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the albizia tree is
- 2 an invasive species that can grow up to one hundred fifty feet
- 3 tall. The tree can grow in nutrient-deficient soils, produces
- 4 large quantities of wind-dispersed seeds, and grows at a very
- 5 rapid rate, gaining up to fifteen feet in height each year. It
- 6 can very quickly disrupt and replace native ecosystems and can
- 7 easily take over a cleared area in just a few years.
- 8 The legislature further finds that albizia trees have very
- 9 brittle trunks and limbs that are structurally weak and are
- 10 prone to "sudden limb shear", a phenomenon in which live
- 11 branches collapse without warning or apparent cause. These
- 12 collapses can occur even if the tree appears to be healthy.
- 13 This phenomenon, combined with the tree's large size and fast
- 14 growth, gives the tree the potential to cause major damage to
- 15 property, infrastructure, and human life. As a result, state
- 16 and county agencies and utility companies must constantly remove



1	albizia crees. There are currently rew beneficial uses for the
2	removed albizia trees.
3	However, the legislature finds that there may be a number
4	of beneficial uses for albizia wood. For example, in 2018, a
5	former university of Hawaii student led a team that successfully
6	constructed a full-size prototype single-family home built from
7	albizia wood. The project demonstrated that albizia could be
8	used as a locally sourced building material. The team indicated
9	that there remained questions about whether the use of albizia
10	wood for construction was economically feasible and whether
11	builders could achieve economies of scale using the wood. If
12	questions like these are answered, the State could turn its
13	overabundance of albizia trees into economic opportunities.
14	Accordingly, the purpose of this Act is to require the
15	department of business, economic development, and tourism to:
16	(1) Create a grant program to assist persons who use
17	albizia trees to create usable products or are
18	developing new ways to use albizia trees to create
19	usable products; and

1	(2) Study economically feasible way	s in which businesses	
2	may use albizia trees to produc	e usable products,	
3	including housing, throughout t	he State.	
4	SECTION 2. Chapter 201, Hawaii Revi	sed Statutes, is	
5	amended by adding a new section to part I to be appropriately		
6	designated and to read as follows:		
7	"§201- Albizia products; grant p	rogram. (a) The	
8	department shall establish a grant program to assist persons		
9	who:		
10	(1) Use albizia trees to create usa	ble commercial	
11	products; or		
12	(2) Are developing new ways of usin	g albizia trees to	
13	create usable commercial produc	ts.	
14	(b) The department shall adopt rule	s pursuant to chapter	
15	91 that establish criteria for the award of grant funding and		
16	implement a process to facilitate the award of grants. The		
17	rules shall include the following terms and conditions, at a		
18	minimum:		
19	(1) The products being created, dev	eloped, or studied	
20	shall primarily use albizia woo	d. For purposes of	
21	this paragraph, whether a produ	ct primarily uses	

1		albizia wood shall be determined pursuant to	
2	guidelines established by rule;		
3	(2) Qualifying applicants shall include corporations,		
4	limited liability companies, partnerships, sole		
5	proprietorships, non-profit organizations, and		
6		cooperatives having a certificate of vendor compliance	
7		with Hawaii compliance express; and	
8	(3)	The manufacture and assembly of the products shall	
9		take place within the State.	
10	(c)	Grants shall be awarded subject to the availability of	
11	funds. No person shall receive grants, in aggregate, that		
12	exceed \$ in a single calendar year.		
13	(d) No later than twenty days prior to the convening of		
14	each regular session, the department shall submit to the		
15	legislature a report describing the results of the grant		
16	program, including the total number of grants awarded and a		
17	summary of the products created or developed using grant		
18	moneys."		
19	SECTION 3. (a) The department of business, economic		
20	developme	nt, and tourism shall study economically feasible ways	

- 1 in which businesses may use albizia trees to produce usable
- 2 commercial products, including housing, throughout the State.
- 3 (b) In conducting the study, the department shall consult
- 4 with the university of Hawaii college of tropical agriculture
- 5 and human resources and the university of Hawaii school of
- 6 architecture.
- 7 (c) The department of business, economic development, and
- 8 tourism shall submit a report of its findings and
- 9 recommendations, including any proposed legislation, to the
- 10 legislature no later than twenty days prior to the convening of
- 11 the regular session of 2024.
- 12 SECTION 4. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2023-2024 for
- 15 the grant program established by section 2 of this Act.
- 16 The sum appropriated shall be expended by the department of
- 17 business, economic development, and tourism for the purposes of
- 18 this Act.
- 19 SECTION 5. New statutory material is underscored.

1 SECTION 6. This Act shall take effect on July 1, 2023.
