# A BILL FOR AN ACT

RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 9, Hawaii Revised Statutes, is amended
2	by adding two new sections to be appropriately designated and to
3	read as follows:
4	"§9- Art in private places and performing arts
5	committee. (a) There is established an art in private places
6	and performing arts committee to be placed within the state
7	foundation on culture and the arts for administrative purposes.
8	(b) The art in private places and performing arts
9	committee shall comprise the following members:
10	(1) The executive director of the state foundation on
11	culture and the arts, or the executive director's
12	designee, who shall serve as chairperson;
13	(2) The chairpersons of the senate and house of
14	representatives standing committees whose purview is
15	culture and the arts; and

1	(3)	Two members who represent the performing arts
2		community, who shall be selected by the chairperson
3		and invited to participate.
4	(c)	The art in private places and performing arts
5	committee	shall establish the art in private places pilot
6	program ar	nd performing arts pilot program, under which the
7	committee	shall:
8	(1)	Oversee the implementation of the art in private
9		<pre>places pilot program;</pre>
10	(2)	Solicit proposals for performing arts grants;
11	(3)	Review grant proposals and select proposals
12		appropriate for funding; and
13	(4)	Evaluate outcomes of grant proposals.
14	<u>(d)</u>	The art in private places and performing arts
15	committee	shall submit annual reports of:
16	(1)	The status of the art in private places pilot program
17		and the revenue generated from the program; and
18	(2)	Funded performing arts proposals and the outcomes of
19		each event,

1	to the le	gislature no later than twenty days prior to the
2	convening	of each regular session beginning with the regular
3	session o	f 2024.
4	<u>(e)</u>	For the purposes of this section, "private places"
5	means non	-state owned, publicly accessible areas and city and
6	county bu	ildings.
7	<u>§</u> 9-	Performing arts special account. There is
8	establish	ed in the state treasury the performing arts special
9	account i	nto which shall be deposited:
10	(1)	Revenues from the performing arts pilot program;
11	(2)	Revenues from the art in private places pilot program;
12	(3)	Gifts, grants, and other funds for performing arts
13		accepted by the foundation;
14	(4)	Appropriations by the legislature to the performing
15		arts special account; and
16	(5)	All interest and revenues or receipts derived by the
17		foundation from performing arts events, including:
18		(A) Rents, fees, and charges for the use of
19		<pre>facilities;</pre>
20		(B) Concession agreements and other use agreements;

1	(C) Revenues generated from agreements to record
2	performances negotiated by the foundation.
3	Moneys in the account shall be used for coordinating, planning,
4	promoting, marketing, and executing performing arts events;
5	provided that not more than per cent shall be used for
6	administrative expenses."
7	SECTION 2. Chapter 9, Hawaii Revised Statutes, is amended
8	by amending the title of part III to read as follows:
9	"[+]PART III.[+] ART IN PUBLIC PLACES AND RELOCATABLE WORKS of
10	[+]ART[+] PROGRAMS, PERFORMING ARTS, AND STATE ART MUSEUM"
11	SECTION 3. Section 9-21, Hawaii Revised Statutes, is
12	amended to read as follows:
13	"[+]§9-21[+] Purpose. The foundation shall administer the
14	art in public places and relocatable works of art programs,
15	pursuant to section 103-8.5, the performing arts pilot program,
16	and the state art museum to achieve the following purposes:
17	(1) Replace in public state buildings the natural beauty
18	displaced in construction with works of art expressive
19	of the State's cultural, creative, and traditional
20	arts of its various ethnic groups;

1	(2)	Support, promote, and recognize excellence of the
2		State's diverse cultural, creative, and traditional
3		artists; [and]
4	(3)	Create, display, and maintain in public places and the
5		state art museum a collection of works of art that:
6		(A) Represents the diversity and excellence of the
7		State's artistic expression; and
8		(B) Provides to all the citizens of the State the
9		fullest possible access to the highest quality
10		aesthetic and educational experiences
11		available[-]; and
12	(4)	Coordinate, plan, promote, market, and execute the
13		performing arts pilot program.
14	As u	sed in this section, "performing arts" include arts or
15	skills th	at are intended to be performed before an audience
16	including	, dance, singing, musical performances, and theatre."
17	SECT	ION 4. There is appropriated out of the general
18	revenues	of the State of Hawaii the sum of \$ or so
19	much ther	eof as may be necessary for fiscal year 2023-2024 and
20	the same	sum or so much thereof as may be necessary for fiscal

1	year 2024-2025 to the state foundation on culture and the arts
2	for:
3	(1) Establishing and implementing the art in private
4	places and performing arts pilot programs; and
5	(2) Establishing one full-time equivalent (1.0 FTE)
6	permanent position to oversee the pilot programs
7	established by this Act.
8	The sums appropriated shall be expended by the state
9	foundation on culture and the arts for the purposes of this Act
10	SECTION 5. Statutory material to be repealed is bracketed
11	and stricken. New statutory material is underscored.

SECTION 6. This Act shall take effect on June 30, 3000.

#### Description:

Establishes the Art in Private Places and Performing Arts Committee to establish the Art in Private Places and Performing Arts Pilot Programs to select, review, and fund grant proposals for performing arts events. Clarifies the scope of the State Foundation on Culture and the Arts' responsibilities to include administration of the Performing Arts Pilot Program. Appropriates funds to the State Foundation on Culture and the Arts for the Art in Private Places and Performing Arts Pilot Programs and to establish 1 position for the State Foundation on Culture and the Arts. Requires annual reports to the Legislature. Effective 6/30/3000. (SD2)
