A BILL FOR AN ACT

RELATING TO COMPUTER SCIENCE EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the importance of
- 2 computer science cannot be overstated. Computers have evolved
- 3 to become a part of everyday life, and an introduction to
- 4 computer science helps students better understand their digital
- 5 world and become problem solvers of the future.
- 6 According to the Bureau of Labor Statistics, the United
- 7 States will continue to be transformed by technological
- 8 advancements rooted in computer programs and applications over
- 9 the next ten years. Consequently, computing-based occupations
- 10 now make up more than half of all projected new jobs in the
- 11 science, technology, engineering, and mathematics fields,
- 12 commonly known as STEM fields. In the prior decade between 2010
- 13 and 2020, the number of computer science bachelor's degrees
- 14 conferred more than doubled from 39,600 to 97,000, respectively,
- 15 an increase of one hundred forty-five per cent. This means that
- 16 college graduates with computer science degrees have been, and

- 1 will continue to be, in high demand among employers across the
- 2 nation.
- 3 Notwithstanding, national survey and research results show
- 4 a disparity between the demand for computer science education
- 5 and its availability. Although ninety per cent of parents want
- 6 their children's schools to teach computer science, only fifty-
- 7 three per cent of schools offer computer science courses.
- 8 Further, disparities in access and representation remain present
- 9 among traditionally underrepresented groups. For example, women
- 10 make up just one-third of high school computer science students
- 11 nationally.
- 12 In 2018, the legislature found a similar disparity at the
- 13 state level. To address this, the legislature passed Act 51,
- 14 Session Laws of Hawaii 2018, which mandated that all public high
- 15 schools offer at least one computer science course by the 2021-
- 16 2022 school year. In 2021, the legislature further expanded
- 17 those computer science course requirements to elementary,
- 18 middle, and intermediate schools by enacting Act 158, Session
- 19 Laws of Hawaii 2021. As a result, excluding "combo" schools,
- 20 which are schools with combined grade bands (e.g., Lanai High
- 21 and Elementary School), one hundred per cent of public high

- 1 schools now offer a foundational computer science course,
- 2 exceeding the national average, and forty-two per cent of all
- 3 public schools offered a computer science course.
- 4 However, despite the success in expanding access to
- 5 computer science courses since 2018, the State has still fallen
- 6 short on its enrollment goals for these courses. According to
- 7 the department of education's Annual Report on Computer Science
- 8 Courses and Computer Science Content published in November 2022,
- 9 just fourteen per cent of unique students were enrolled in a
- 10 computer science course, with sixteen per cent of those students
- 11 comprising of high school students. Notably, data isolating the
- 12 percentage of high school students enrolled out of total high
- 13 school students was not provided by the report. In sum, the
- 14 legislature finds that promoting computer science education
- 15 remains a statewide necessity.
- 16 Accordingly, the purpose of this Act is to promote computer
- 17 science education in the State by:
- 18 (1) Allowing students to complete computer science courses
- as a substitute for science courses at the high school
- 20 level to satisfy graduation credit requirements;

1	(2)	Requiring a computer science course credit as a
2		graduation requirement at the high school level
3		beginning with the 2030-2031 school year; and
4	(3)	Appropriating funds to the department of education for
5		teacher professional development in computer science.
6	SECT	ION 2. Section 302A-323, Hawaii Revised Statutes, is
7	amended t	o read as follows:
8	" §30	2A-323 Computer science; curricula plan; public
9	schools.	(a) The department shall:
10	(1)	Develop and implement a statewide computer science
11		curricula plan for public school students in
12		kindergarten through twelfth grade that may include
13		design thinking as part of the curricula; and
14	(2)	Beginning with the 2021-2022 school year, ensure that
15		each public high school offers at least one computer
16		science course during each school year [+]; provided
17		that, beginning with the 2024-2025 school year,
18		students shall be allowed to complete computer science
19		courses as a substitute for science courses to satisfy
20		graduation credit requirements.

- 1 (b) Beginning with the 2022-2023 school year, at least one
- 2 public elementary school and one public middle or intermediate
- 3 school in each complex area shall offer computer science courses
- 4 or computer science content.
- 5 (c) Beginning with the 2023-2024 school year, no less than
- 6 fifty per cent of the public elementary schools and no less than
- 7 fifty per cent of the public middle and intermediate schools in
- 8 each complex area shall offer computer science courses or
- 9 computer science content.
- 10 (d) Beginning with the 2024-2025 school year, all public
- 11 elementary, middle, and intermediate schools shall offer
- 12 computer science courses or computer science content.
- (e) Beginning with the 2030-2031 school year, all public
- 14 high schools shall require a computer science course credit as a
- 15 graduation requirement; provided that a public high school may
- 16 apply for a one-time two-year waiver from the requirements of
- 17 this subsection subject to board approval.
- 18 $[\frac{(e)}{(e)}]$ (f) By June 30, 2022, and by each June 30
- 19 thereafter, the superintendent shall submit to the board and
- 20 legislature a report of the computer science courses and

17	(1)	Who is physically located at the school; or
18	(2)	Who is not physically located at the school but
19		provides instruction through virtual means with the
20		assistance of a proctor who is physically located at
21		the school."
