A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of 2 human resources development is committed to making the State a 3 desirable place to work and supporting the approximately fourteen thousand employees who work throughout the State. 4 5 The legislature also finds that the department of human 6 resources development's information technology systems require 7 additional investment and modernization. Specifically, by 8 upgrading or replacing equipment, hiring key information 9 technology personnel, upgrading the existing outdated network 10 infrastructure, and providing necessary training, the department 11 of human resources development will be able to hire new, essential state workers more quickly and provide the department 12 13 with the assets it needs to function more efficiently overall. 14 Accordingly, the purpose of this Act is to appropriate 15 moneys to the department of human resources development to: 16 Establish two full-time equivalent (2.0 FTE) (1)17 information technology specialist positions; and

There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$ or so 7 much thereof as may be necessary for fiscal year 2023-2024 and 8 the same sum or so much thereof as may be necessary for fiscal 9 year 2024-2025 for the establishment of two full-time equivalent 10 (2.0 FTE) information technology specialist positions within the 11 department of human resources development. 12 The sums appropriated shall be expended by the department 13 of human resources development for the purposes of this Act. 14 SECTION 3. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$ or so 16 much thereof as may be necessary for fiscal year 2023-2024 to 17 upgrade information technology systems within the department of 18 human resources development, including network upgrades; 19 purchase and install desktop computers, workstations, and laptop 20 computers; and train personnel.
