BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 201H, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part III to be appropriately
- 3 designated and to read as follows:
- 4 "\\$201H- Applications for financing; application
- 5 periods. If sufficient funding is available, the corporation
- 6 shall open at minimum two application periods each year for the
- 7 receipt of applications for financing from parties interested in
- 8 applying for financing for the development of affordable housing
- 9 in the State from the low-income housing tax credit program,
- 10 Hula Mae multi-family program, rental housing revolving fund
- 11 program, and dwelling unit revolving fund program. Applications
- 12 for the four programs may be consolidated for administrative
- 13 efficiency."
- 14 SECTION 2. New statutory material is underscored.
- 15 SECTION 3. This Act shall take effect upon its approval.
