A BILL FOR AN ACT

RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that much of the State's 2 aging public housing stock has fallen into disrepair. Without 3 adequate reinvestment, deteriorating structural conditions can 4 worsen and pose significant risks to many low-income families 5 who need or already receive housing assistance. The legislature 6 also finds that public housing vacancies have hindered the 7 State's efforts to expand affordable housing availability at a 8 time when it is most desperately needed.

9 The legislature further finds that the Hawaii public 10 housing authority is responsible for administering a federal and 11 state low-income public housing program. With properties 12 statewide, the Hawaii public housing authority manages 13 approximately 6,270 units of public housing throughout the 14 State. The Hawaii public housing authority estimates that there 15 are currently three hundred dwelling units lying vacant because 16 they require extensive capital repairs.

1 The legislature additionally finds that a significant 2 majority of Hawaii's public housing residents have household 3 incomes of less than thirty per cent of the applicable area median income, with few exceptions. Local demand for affordable 4 5 rental units continues to greatly outpace the construction of any new supply. The legislature notes that housing developers 6 7 often struggle to make such projects pencil out. Many housing 8 developers also find projects completely cost-prohibitive. As 9 such, the legislature believes repairing vacant public housing 10 units offers a partial, yet straightforward solution to easing 11 Hawaii's affordable housing crisis. The Hawaii public housing 12 authority anticipates that these vacant units could be made 13 habitable again in as quickly as eighteen months. 14 Accordingly, the purpose of this Act is to appropriate 15 funds to repair and improve the quality of the State's existing 16 public housing in order to expand affordable housing 17 opportunities for Hawaii's most disadvantaged families. 18 SECTION 2. There is appropriated out of the general

1 year 2024-2025 for the Hawaii public housing authority to 2 contract out; without regard to chapter 76, Hawaii Revised 3 Statutes; for the repair, renovation, improvements, and maintenance of federal and state low-income public housing units 4 from July 1, 2023, to June 30, 2025. 5 6 The sums appropriated shall be expended by the Hawaii 7 public housing authority for the purposes of this Act. 8 SECTION 3. The Hawaii public housing authority shall 9 submit reports of completed and pending projects, and the 10 timeframe or timeline of each project, funded under this Act to 11 the legislature no later than twenty days prior to the convening 12 of the regular sessions of 2024 and 2025.

13 SECTION 4. This Act shall take effect on July 1, 3000.
