### A BILL FOR AN ACT

RELATING TO NATIVE HAWAIIAN TRADITIONAL AND CUSTOMARY FISHING PRACTICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of 2 land and natural resources is responsible for managing and 3 administering the aquatic wildlife resources of the State. The 4 department utilizes a variety of management tools to increase 5 yields for Hawaii fishers and protect aquatic resources from 6 overexploitation. Management tools such as size limits, bag 7 limits, closed seasons, gear and method regulations, and place-8 based fishing restrictions are all vital aspects of the 9 department's mission to increase fish yields and conserve 10 Hawaii's natural aquatic resources for future generations.

11 The legislature recognizes that article XII, section 7, of 12 the Hawaii State Constitution provides protections for "all 13 rights, customarily and traditionally exercised for subsistence, 14 cultural and religious purposes and possessed by ahupua'a tenants 15 who are descendants of native Hawaiians who inhabited the

Hawaiian Islands prior to 1778, subject to the right of the
 State to regulate such rights."

3 The legislature further finds that despite these 4 constitutional protections, individuals who choose to exercise 5 their rights to gather aquatic resources in ways that contravene 6 state fishing laws are subjected to the risk of civil and 7 criminal citation and arrest before being afforded an 8 opportunity to validate their traditional and customary rights. 9 Allowing for permits to be issued by the department of land and 10 natural resources for the purpose of exercising traditional and 11 customary fishing practices would provide a less burdensome 12 avenue for individuals to lawfully exercise legitimate 13 traditional and customary fishing practices protected by the 14 Hawaii State Constitution.

15 The purpose of this Act is to provide the department with 16 the authority to issue special activity permits for the purpose 17 of recognizing and protecting individuals exercising their right 18 to engage in traditional and customary fishing practices as 19 protected by the Hawaii State Constitution.

20 SECTION 2. Section 187A-6, Hawaii Revised Statutes, is
21 amended to read as follows:

1 "§187A-6 Special activity permits. (a) Notwithstanding 2 the provisions of any other law, the department may take aquatic 3 life or possess or use any fishing gear for scientific, 4 educational, management, or propagation purposes, for removal of 5 aquatic species, or for implementing the powers and duties as 6 described by section 187A-2; subject to chapter 195D. The 7 department shall consider using chemicals or electrofishing 8 devices only when it has determined that no other reasonable 9 alternative would be appropriate. The application of chemicals 10 or operation of electrofishing devices shall be in accordance 11 with established procedures and with the proper training to 12 ensure that the intended results are achieved.

13 Notwithstanding the provisions of any other law, the (b) 14 department may issue permits, not longer than one year in 15 duration, to any person to take aquatic life, possess or use 16 fishing gear, or engage in any feeding, watching, or other such 17 non-consumptive activity related to aquatic resources, otherwise 18 prohibited by law, in any part of the State, for scientific, 19 educational, management, or propagation purposes, subject to 20 chapter 195D and subject to those restrictions the department 21 deems desirable. The department may revoke any permit for any

1 infraction of the terms and conditions of the permit. Any 2 person whose permit has been revoked shall not be eligible to 3 apply for another permit until the expiration of one year from 4 the date of revocation. (c) The department may issue a permit to any person 5 6 exercising the person's Native Hawaiian traditional and 7 customary practices protected by law to take aquatic life; 8 possess or use fishing gear; or engage in any feeding, watching, 9 or other such non-consumptive activity related to aquatic 10 resources, otherwise prohibited by law, in any part of the 11 State, subject to chapter 195D. The permit authorized by this 12 subsection is not required by any person exercising the person's 13 constitutionally protected traditional and customary practices, 14 but is intended to assist in the recognition and protection of any person exercising the person's protected rights. 15 16 [(c)] (d) The department may adopt rules pursuant to 17 chapter 91 for the purpose of this section. 18 [(d)] (e) For the purposes of this section, unless the 19 context clearly indicates otherwise:
