# A BILL FOR AN ACT

RELATING TO THE CONSERVATION AND RESOURCES ENFORCEMENT PROGRAM.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the conservation and
- 2 resources enforcement program of the department of land and
- 3 natural resources shoulders responsibilities that are integral
- 4 to preserving the public peace and safety. Specifically, the
- 5 program is responsible for enforcing laws on public lands and
- 6 waters of the State.
- 7 The legislature recognizes that proper training, equipment,
- 8 and organizational support are imperative to the success of law
- 9 enforcement officers in the conservation and resources
- 10 enforcement program. To this end, the department of land and
- 11 natural resources division of conservation and resources
- 12 enforcement established an academy to better train law
- 13 enforcement officers.
- 14 The legislature further finds that the Commission on
- 15 Accreditation for Law Enforcement Agencies, Inc., created in
- 16 1979, serves as a law enforcement credentialing authority
- 17 through collaboration with law enforcement executive



- 1 associations. The Honolulu and Maui police departments are
- 2 accredited by the Commission on Accreditation for Law
- 3 Enforcement Agencies, Inc., and the sheriff division of the
- 4 department of public safety is required to obtain accreditation
- 5 pursuant to section 353C-9, Hawaii Revised Statutes.
- 6 The legislature further recognizes that the conservation
- 7 and resources enforcement program was previously required to
- 8 obtain accreditation from the Commission on Accreditation for
- 9 Law Enforcement Agencies, Inc. As recently as 2020, the
- 10 conservation and resources enforcement program was required to
- 11 obtain accreditation from the Commission on Accreditation for
- 12 Law Enforcement Agencies, Inc., in the use of electric guns, but
- 13 Act 183, Session Laws of Hawaii 2021, inadvertently repealed
- 14 that requirement when it repealed the entirety of section
- 15 134-16, Hawaii Revised Statutes.
- 16 The purpose of this Act is to require the department of
- 17 land and natural resources to seek and obtain accreditation for
- 18 the conservation and resources enforcement program from the
- 19 Commission on Accreditation for Law Enforcement Agencies, Inc.
- SECTION 2. No later than June 30, 2029, the department of
- 21 land and natural resources shall pursue and obtain accreditation

- 1 for the conservation and resources enforcement program from the
- 2 Commission on Accreditation for Law Enforcement Agencies, Inc.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2023-2024 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2024-2025 for the department of land and natural resources
- 8 to pursue and obtain accreditation for the conservation and
- 9 resources enforcement program from the Commission on
- 10 Accreditation for Law Enforcement Agencies, Inc.
- 11 The sums appropriated shall be expended by the department
- 12 of land and natural resources for the purposes of this Act.
- 13 SECTION 4. This Act shall take effect on June 30, 3000.
