A BILL FOR AN ACT

RELATING TO BACKGROUND CHECKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 human services assists vulnerable persons, including minors,
- 3 young adults, and vulnerable adults. It is therefore necessary
- 4 for the department to exercise caution when employing or
- 5 retaining workers, including volunteers, contractors, and
- 6 others, whose positions place them in close proximity with
- 7 persons who may be at risk.
- 8 Accordingly, the purpose of this Act is to help ensure the
- 9 safety of vulnerable persons by authorizing the department of
- 10 human services to conduct comprehensive background checks on
- 11 current or prospective employees; volunteers; contractors; and
- 12 contractors' employees, agents, and volunteers, whose position
- 13 places or would place them in close proximity to certain minors,
- 14 young adults, or vulnerable adults.
- 15 SECTION 2. Section 346-2.5, Hawaii Revised Statutes, is
- 16 amended to read as follows:

- 1 "[+]\$346-2.5[] Criminal history record] Background checks.
- 2 (a) The department shall develop procedures for obtaining
- 3 verifiable information regarding the criminal history of any
- 4 person who is employed or seeking employment, including a
- 5 contractor and its employees or agents if prior authority to
- 6 access federal tax information has been provided by the United
- 7 States Department of the Treasury, if the person will require
- 8 access to federal tax information. The procedures shall include
- 9 criminal history record checks in accordance with section
- 10 846-2.7. Information obtained pursuant to this subsection shall
- 11 be used exclusively by the department for the purpose of
- 12 determining whether a person is suitable for accessing federal
- 13 tax information in accordance with applicable federal laws.
- 14 (b) The department may terminate or deny employment to any
- 15 current or prospective employee [or applicant,] or terminate or
- 16 refuse to secure the services of a contractor and its employees
- 17 or agents authorized under subsection (a), if the department
- 18 finds by reason of the nature and circumstances of the
- 19 background investigation conducted under subsection (a) that the
- 20 <u>current or prospective</u> employee[, applicant, or contractor, or
- 21 contractor's employees or agents pose a risk to the security of

- 1 federal tax information. Termination or denial of employment or
- 2 refusal to secure services under this subsection shall only
- 3 occur after appropriate notification to the current or
- 4 prospective employee[, applicant,] or contractor of the findings
- 5 of the background investigation, and after the current or
- 6 prospective employee[applicant,] or contractor is given an
- 7 opportunity to respond to the findings. Nothing in this
- 8 subsection shall abrogate any applicable appeal rights under
- 9 chapters 76 and 89, or administrative rules of the department.
- 10 (c) The department shall develop procedures for obtaining
- 11 verifiable information regarding the criminal history, and
- 12 information confirming the reputable and responsible character,
- 13 of any current or prospective employee; volunteer; contractor;
- 14 or contractor's employee, agent, or volunteer, who will be in
- 15 close proximity to minors, young adults, or vulnerable adults
- 16 who are receiving from the department:
- 17 (1) Child welfare services;
- 18 (2) Social services;
- 19 (3) Services intended to prevent abuse or neglect; or

- 2 to work in close proximity to minors, young adults, or
- 3 vulnerable adults.
- 4 (e) The department may periodically obtain criminal
- 5 history information on all persons who are subject to this
- 6 <u>section through the Hawaii criminal justice data center.</u>
- 7 (f) The department may terminate or deny employment to a
- 8 current or prospective employee or volunteer, or terminate or
- 9 refuse to secure the services of a contractor or the
- 10 contractor's employees, agents, or volunteers if the department
- 11 finds, based on the results of the background investigation
- 12 conducted pursuant to subsections (d) and (e), that the current
- 13 or prospective employee; volunteer; contractor; or contractor's
- 14 employee, agent, or volunteer may pose a risk to the health,
- 15 safety, security, or well-being of minors, young adults, or
- 16 vulnerable adults as described in subsection (c). Termination
- 17 or denial of employment or refusal to secure services under this
- 18 subsection shall occur only after the department notifies the
- 19 current or prospective employee or contractor of the findings of
- 20 the background investigation, and after the current or
- 21 prospective employee or contractor is given an opportunity to

- 1 respond to the findings. Nothing in this subsection shall
- 2 abrogate any applicable rights to appeal under chapters 76 and
- 3 89 or the administrative rules of the department.
- 4 [(c)] (g) The department shall be exempt from section
- 5 831-3.1 and need not conduct investigations, notifications, or
- 6 hearings under this section in accordance with chapter 91.
- 7 (h) For purposes of this section:
- 8 "Vulnerable adult" has the same meaning as defined in
- **9** section 346-222.
- 10 "Young adult" means a person between the ages of eighteen
- 11 and twenty-one or a person authorized by the Foster Care
- 12 Independence Act of 1999 (Pub. L. 106-169), or other applicable
- 13 law, regardless of age, to receive benefits and services aimed
- 14 at assisting youth aging out of foster care in the United States
- 15 in obtaining and maintaining independent living skills."
- 16 SECTION 3. Section 378-2.5, Hawaii Revised Statutes, is
