## A BILL FOR AN ACT

RELATING TO TELECOMMUNICATIONS ACCESS FOR INDIVIDUALS WITH PRINT DISABILITIES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the public utilities
2	commission has a duty and obligation to obtain and maintain
3	access to a basic set of essential telecommunications services
4	for individuals who are blind or visually impaired.
5	The purpose of this Act is to require the public utilities
6	commission to provide free telecommunications access to certain
7	information for persons with a print disability through use of
8	the universal service fund.
9	SECTION 2. Chapter 269, Hawaii Revised Statutes, is
10	amended by adding a new section to part I to be appropriately
11	designated and to read as follows:
12	" <u>§269-</u> Universal service program; access for
13	individuals with print disabilities. (a) The public utilities
14	commission shall, as authorized by the legislature, use
15	available funds from the universal service fund established
16	pursuant to section 269-42 to provide free telecommunications

1	access to time-sensitive information, including but not limited						
2	to state and local government information, public notices,						
3	emergency alerts, job opportunities, daily newspapers, and other						
4	content, to allow individuals with a print disability to access						
5	information and services; provided that the amount of funds						
6	withdrawn from the universal service fund shall not exceed						
7	5 . The telecommunications access shall be configured						
8	to be accessible to and usable by persons with print						
9	disabilities.						
10	(b) The public utilities commission shall adopt rules						
11	pursuant to chapter 91 to implement this section."						
12	SECTION 3. There is appropriated out of the general						
13	revenues of the State of Hawaii the sum of \$ or so						
14	much thereof as may be necessary for fiscal year 2023-2024 and						
15	the same sum or so much thereof as may be necessary for fiscal						
16	year 2024-2025 to provide free telecommunications access to						
17	certain information for persons with a print disability.						
18	The sums appropriated shall be expended by the public						
19	utilities commission for the purposes of this Act.						
20	SECTION 4. New statutory material is underscored.
