# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that residents of and visitors to the State often have difficulty finding the application process needed to use lands administered by the
- 4 department of land and natural resources that are publicly
- 5 available for recreational purposes, including placing a
- 6 reservation for a state park camping permit or obtaining a
- 7 freshwater game fishing license to fish for certain species or
- 8 to fish in certain areas. Commercial operators desiring to
- 9 enter the market in the State are also frequently confused about
- 10 the required authorizations, licenses, and permits necessary to
- 11 operate on areas administered by the department of land and
- 12 natural resources, leading to a variety of illegal and
- unauthorized commercial offerings on the lands.
- 14 The legislature further finds that to find the information
- 15 to begin the application process, an individual must navigate
- 16 from the department of land and natural resources home website
- 17 through multiple links to find the appropriate division website

- 1 that contains the desired information and forms to go through
- 2 the application process. A website that consolidates all of the
- 3 forms and application processes required by the department of
- 4 land and natural resources to conduct outdoor recreational and
- 5 commercial activities in the State will help to streamline the
- 6 application process and be of great benefit to Hawaii's
- 7 residents, visitors, and commercial operators.
- 8 The purpose of this Act is to require and appropriate funds
- 9 to the department of land and natural resources to develop and
- 10 publish a website that contains the application processes
- 11 necessary to acquire a permit, license, or reservation to
- 12 conduct recreational and commercial activities that are
- 13 regulated by or under the jurisdiction of the department.
- 14 SECTION 2. (a) No later than , the department
- 15 of land and natural resources shall develop and publish a
- 16 website that includes all online application processes necessary
- 17 to acquire a permit, license, or reservation needed to conduct
- 18 recreational and commercial activities in the State that are
- 19 regulated by or under the jurisdiction of the department,
- 20 including but not limited to:
- 21 (1) Permits for a campsite, cabin, or pavilion;

1	(2)	Licenses and permits to hunt or catch or hatch aquatic
2		life or marine life, as allowed by state and federal
3		law;
4	(3)	Reservations to access certain state parks;
5	(4)	Access, collection, research, and other required
6		activities;
7	(5)	Film permits;
8	(6)	Permits to conduct commercial tours;
9	(7)	Permits to conduct boating activities; and
10	(8)	Licenses and permits for any other authorized
11		recreational and commercial activities regulated by
12		the department.

15	including	forms required by the application process and the
16	acceptanc	e of any fee payments, to acquire a permit, license, or

19	jurisdict	ion of the department into a digital format to be used
20	in the ap	plication processes on the department's website
21	establish	ed pursuant to subsection (a).

1	(c) No later than December 1, 2023, the department of land
2	and natural resources shall submit to the legislature a report
3	regarding its implementation of this Act.
4	SECTION 3. There is appropriated out of the general
5	revenues of the State of Hawaii the sum of \$ or so
6	much thereof as may be necessary for fiscal year 2023-2024 and
7	the same sum or so much thereof as may be necessary for fiscal
8	year 2024-2025 for the establishment of a website as required
9	pursuant to section 2 of this Act.
10	The sums appropriated shall be expended by the department
11	of land and natural resources for the purposes of this Act.
12	SECTION 4. This Act shall take effect on June 30, 3000.

### Description:

Requires DLNR to develop and publish a website that includes the application processes for a permit, license, or reservation needed to conduct recreational and commercial activities in the State that are regulated by or under the jurisdiction of the department. Requires DLNR to convert existing application processes into a digital format to be used on the website. Appropriates funds for the establishment of the website. Effective 6/30/3000. (HD1)
