

A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. There is appropriated out of the general
3	revenues of the State of Hawaii the sum of \$ or so much
4	thereof as may be necessary for fiscal year 2023-2024 and the
5	same sum or so much thereof as may be necessary for fiscal year
6	2024-2025 to be deposited into the preschool open doors special
7	fund.
8	SECTION 2. There is appropriated out of the preschool open
9	doors special fund the sum of \$ or so much thereof as
10	may be necessary for fiscal year 2023-2024 and the same sum or
11	so much thereof as may be necessary for fiscal year 2024-2025
12	for the preschool grant program, the hiring of three temporary
13	information technology positions without regard to chapter 89,
14	Hawaii Revised Statutes, to support modifications to the
15	preschool open doors program, and the data governance issues
16	necessitated by Act 46, Session Laws of Hawaii 2020, and Act
17	210, Session Laws of Hawaii 2021. Funds appropriated pursuant

1 to this section may also be expended on additional permanent staff, benefit expenses related to the new staff, and costs 2 3 associated with necessary modifications to the preschool open 4 doors program. Funds appropriated pursuant to this section may 5 be expended without regard to chapters 103D and 103F, Hawaii 6 Revised Statutes, as the case may be. 7 The sums appropriated shall be expended by the department 8 of human services for the purposes of this Act. 9 PART II SECTION 3. Section 346-184, Hawaii Revised Statutes, is 10 11 amended by amending subsection (b) to read as follows: 12 "(b) Accreditation under this section shall be obtained 13 from one or more of the following national early learning 14 accrediting organizations: 15 (1) National Association for the Education of Young 16 Children: 17 (2) National Early Childhood Program Accreditation; 18 (3) National Association for Family Child Care; or 19 (4)An accrediting organization approved by the director[+ 20 provided that the accrediting organization is

1	comparable to the organizations specified in
2	paragraphs (1) through (3)]."
3	PART III
4	SECTION 4. Section 302L-7, Hawaii Revised Statutes, is
5	amended by amending subsection (c) to read as follows:
6	"(c) The program shall serve [children in the year prior
7	to the year of kindergarten eligibility, three- and four-year-
8	old children who are in the two years prior to kindergarten
9	entry pursuant to section 302A-411, with priority extended to
10	underserved or at-risk children, as defined in section 302L-1,
11	and follow the academic year schedule of the department of
12	education and be aligned with the full-day kindergarten
13	classroom schedule of each school. Enrollment priority shall be
14	given but is not limited to children who attend prekindergarten
15	at schools to which the children will be assigned upon entering
16	kindergarten under section 302A-1143."
17	SECTION 5. Section 346-181, Hawaii Revised Statutes, is
18	amended by amending subsection (b) to read as follows:
19	"(b) Subject to the availability of funds, the program
20	shall serve three- and four-year-old children[-] who are in the

1	two years	prior to kindergarten entry pursuant to section
2	302A-411,	with priority extended in the following order to:
3	(1)	Children who are not eligible to attend public school
4		kindergarten in the calendar year in which they turn
5		five years of age because their birth date occurs
6		after the kindergarten eligibility date pursuant to
7		section 302A-411; [and]
8	(2)	Underserved or at-risk [children,] four-year-old
9		children who were previously served as a three-year-
10		old child, as defined by rules adopted by the
11		department[-];
12	(3)	Four-year-old children who were previously served as a
13		three-year-old child;
14	(4)	Four-year-old children;
15	(5)	Underserved or at-risk three-year-old children, as
16		defined by rules adopted by the department; and
17	(6)	Three-year-old children."
18	SECT:	ION 6. Section 346-182, Hawaii Revised Statutes, is
19	amended by	y amending subsection (a) to read as follows:
20	"(a)	There is established within the state treasury the
21	nreschool	open doors special fund to be administered by the

1 department's child care assistance program, into which shall be 2 deposited all moneys received by the department's child care 3 assistance program in the form of: 4 (1)Fees; 5 (2) Grants; 6 (3) Donations; 7 (4)Appropriations made by the legislature to the fund; 8 (5) Federal funds; 9 $[\frac{(5)}{}]$ (6) Revenues regardless of their source; and 10 $[\frac{(6)}{(7)}]$ (7) Earnings on moneys in the fund. Moneys in the fund shall be used for the procurement of health 11 12 and human services under the preschool open doors program. Expenditures from the fund may be made by the department without 13 14 allotment but shall not be made for capital improvement 15 projects." 16 SECTION 7. Act 210, Session Laws of Hawaii 2021, is 17 amended by amending section 14 to read as follows: 18 "SECTION 14. This Act shall take effect upon its approval; 19 provided that: 20 Section 5 shall be repealed on July 1, 2022, and (1)
