A BILL FOR AN ACT

RELATING TO SUSTAINABLE AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the use of cover 2 crops, green manure, and compost increases agricultural 3 productivity and aligns with the State's integrated 4 sustainability goals. Plants used for this purpose, including 5 grasses, legumes, and forbs, add nutrients to the soil, act as 6 windbreaks, assist with water retention, provide habitats for 7 beneficial insects, and help prevent soil erosion. 8 The legislature further finds that it is in the interest of 9 the State to incentivize the use of management practices that 10 enhance the quality and sustainability of Hawaii's agricultural 11 lands. The purpose of this Act is to clarify Act 312, Session 12 Laws of Hawaii 2022, which established a cover crop 13 reimbursement pilot program to reimburse farming operations in 14 the State for the costs of acquiring cover crop seeds, green 15 manure, or compost.

16 SECTION 2. Act 312, Session Laws of Hawaii 2022, is17 amended by amending section 2 to read as follows:

"SECTION 2. (a) The department of agriculture shall
 establish, implement, and administer a three-year cover crop
 reimbursement pilot program to reimburse farming operations in
 the State for the costs of acquiring cover crop seeds, green
 manure, or compost.

6 (b) Each application for cost reimbursement shall be
7 submitted on a form furnished by the department of agriculture
8 and shall be accompanied by documentation of the costs of items
9 purchased, pursuant to subsection (c); provided that:

10 The applicant shall indemnify and hold harmless the (1)11 State and its officers, agents, and employees from all 12 claims arising out of or resulting from the cover crop 13 seeds, green manure, or compost purchased; [and] 14 The department of agriculture may request the (2)15 applicant to provide additional information for the 16 purposes of verifying the volume of cover crop seeds, 17 green manure, or compost purchased [-]; 18 (3) Applications for grants shall be made to the

19 department of agriculture and contain such information
 20 as the department of agriculture shall require. At a
 21 minimum, the applicant shall show:

2	attained the intended results in the manner

4	(7) Grants made by the department of agriculture under
5	this Act may be made without regard to chapters 103D
6	and 103F, Hawaii Revised Statutes.
7	(c) Applications for reimbursement under the cover crop
8	reimbursement pilot program shall be filed for cover crop seeds,
9	green manure, and compost purchased within the fiscal year
10	immediately preceding the filing and shall be effective for
11	costs incurred for purchases after June 30, 2022, but before
12	July 1, 2025. Each application shall include a certification
13	that the amount for which the applicant seeks reimbursement has
14	not been nor will be reimbursed by any other governmental cover
15	crop incentive program, including the United States Department
16	of Agriculture, Natural Resources Conservation Service's
17	environmental quality incentives program and the conservation
18	stewardship program.
19	(d) If an application is approved, funds shall be
20	disbursed upon approval by the department of agriculture on an

or compost purchased after June 30, 2022, but before July 1,
 2025.

3 (e) The department of agriculture shall convene a review 4 panel to be placed within the department of agriculture 5 comprising knowledgeable representatives from the department of agriculture, University of Hawaii at Manoa college of tropical 6 7 agriculture and human resources, and industry 8 organizations. The review panel shall screen and rate 9 applicants on the quality and appropriate use of their cover 10 crops and green manure and their composting practices. The 11 department shall aggregate the total reimbursement applications 12 pursuant to this section and distribute the available moneys 13 based on a ranking scale as determined by the review panel; 14 provided that a higher-ranked applicant shall receive a higher 15 rate of reimbursement than a lower-ranked applicant.

16 (f) There is established within the department of 17 agriculture a cover crop reimbursement pilot program manager 18 position, which shall be a full-time temporary position exempt 19 from the requirements of chapters 76 and 89, Hawaii Revised 20 Statutes. The cover crop reimbursement pilot program manager 21 shall receive a salary not to exceed \$50,000 per year. The 22 cover crop reimbursement pilot program manager shall possess a

1 requisite level of knowledge and expertise in the area of 2 program management necessary to carry out the duties of the 3 position. The cover crop reimbursement pilot program manager 4 shall:

5 (1) Facilitate the division and distribution of available
6 funds for reimbursement; and

7 (2) Manage the day-to-day coordination of the cover crop8 reimbursement pilot program.

9 (g) Any action taken by the department of agriculture
10 pursuant to this section shall be exempt from the rulemaking
11 requirements of chapter 91, Hawaii Revised Statutes.

12 The department of agriculture shall submit an interim (h) 13 report of its findings and recommendations relating to 14 activities conducted pursuant to this Act, including any 15 proposed legislation, to the legislature no later than twenty 16 days prior to the convening of the regular session of 2025 and a 17 final report no later than twenty days prior to the convening of 18 the regular session of 2026. The report shall include the 19 department's recommendation on whether the pilot program should be extended, with or without modifications. 20

22 "Compost" means a product of a composting process.

1	"Compostable materials" includes pre- and post-consumer
2	food waste, waste from animal food processing operations, green
3	waste, crop residues, and waste from vegetable food processing
4	operations and similar materials.
5	"Composting process" means a process in which organic
6	compostable materials are biologically decomposed under
7	controlled conditions to produce a stable humus-like mulch or
8	soil amendment, and includes:
9	(1) The receipt of materials;
10	<pre>(2) Primary processing;</pre>
11	(3) Decomposition activities; and
12	(4) Final processing for sale and marketing.
13	"Cover crop" and "green manure" mean the plants listed in
14	the cover crop and green manure database maintained by the
15	University of Hawaii at Manoa college of tropical agriculture
16	and human resources, except bermuda grass and other invasive or
17	fast-growing grasses.
18	"Farming operation" has the same meaning as in section
19	165-2, Hawaii Revised Statutes."
20	SECTION 3. Statutory material to be repealed is bracketed
21	and stricken. New statutory material is underscored.

Report Title:

Department of Agriculture; Cover Crop Reimbursement Pilot Program

Description:

This housekeeping measure addresses potential deficiencies in Act 312, Session Laws of Hawaii 2022, which established a threeyear cover crop reimbursement pilot program to provide up to 75 per cent cost reimbursement to farming operations in the State for the acquisition of cover crop seeds, green manure, or compost to incentivize such practices.

JUSTIFICATION SHEET H.B.N. 975

DEPARTMENT: AGRICULTURE

TITLE: A BILL FOR AN ACT RELATING TO SUSTAINABLE AGRICULTURE.

- PURPOSE: To clarify the requirements for a three-year cover crop reimbursement pilot program to provide up to 75 percent cost reimbursement to farming operations in the State for the acquisition of cover crop seeds, green manure, or compost to incentivize such practices.
- MEANS: Amend section 2 of Act 312, Session Laws of Hawaii (SLH) 2022.
- JUSTIFICATION: Act 312, SLH 2022, was enacted without the signature of the Governor. The bill seeks to satisfy the legal criteria and standards requirement for distribution of public funds through a grant or subsidy program that the review panel must consider when evaluating application submitted for the program to ensure it can be implemented properly and effectively pursuant to sections 10-17, 201D-11, and 383-128, Hawaii Revised Statutes (HRS), and part II of chapter 9, HRS.

Impact on the public: Incentivizes farmers to build soil health, sequester carbon, and enhance productivity and marketability of their crops.

Impact on the department and other agencies: The department needs clear legal criteria and standards for distribution of public funds through a subsidy program that the review panel must consider when evaluating applications submitted for the program to ensure it can be implemented properly and effectively. The Plant Industry division of the department would collaborate with the College of Tropical Agriculture and Human Resources to do the research to update the

cover crop seed list to protect our pasture and crops from introductions of non-native cover crop species that are hosts to invasive pests and diseases. The department would fund the research and review of the list with funding from the Act. An example of concern is the two-line spittle bug situation on the Big Island.
