A BILL FOR AN ACT

RELATING TO THE AFFORDABLE HOMEOWNERSHIP REVOLVING FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to clarify that the
- 2 \$5,000,000 in general funds that were appropriated in Act 248,
- 3 Session Laws of Hawaii 2022, for the purpose of providing, in
- 4 whole or in part, loans to nonprofit community development
- 5 financial institutions and nonprofit housing development
- 6 organizations for the development of affordable homeownership
- 7 housing projects, is to be deposited into the affordable
- 8 homeownership revolving fund for the purpose for which the
- 9 revolving fund was established. This Act will ensure that loan
- 10 repayments will be made to the affordable homeownership
- 11 revolving fund rather than the general fund.
- 12 SECTION 2. Act 88, Session Laws of Hawaii 2021, as amended
- 13 by Act 248, Session Laws of Hawaii 2022, is amended by amending
- 14 section 6.4 to read as follows:
- 15 "SECTION 6.4. Provided that of the general fund
- 16 appropriation for Hawaii housing finance and development
- 17 corporation (BED160), the sum of \$5,000,000 or so much thereof

- 1 as may be necessary for fiscal year 2022-2023 shall be <u>deposited</u>
- 2 into the affordable homeownership revolving fund established
- 3 pursuant to section 201H-206, Hawaii Revised Statutes, and
- 4 expended for the [purpose of providing, in whole or in part,
- 5 loans to nonprofit community development financial institutions
- 6 and nonprofit housing development organizations for the
- 7 development of affordable homeownership housing projects;
- 8 purposes for which the revolving fund is established; provided
- 9 further that the moneys provided in this section shall not lapse
- 10 at the end of the fiscal year for which the appropriation is
- 11 made; provided further that any moneys that remain unencumbered
- 12 on June 30, 2024, shall lapse on that date."
- 13 SECTION 3. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 4. This Act shall take effect upon its approval.
