HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF HEALTH TO PRIORITIZE TESTING AND RESEARCH OF BEACH SAND CONTAMINATION LEVELS AT POKAI BAY AND REQUESTING THE CITY AND COUNTY OF HONOLULU DEPARTMENT OF PARKS AND RECREATION TO PRIORITIZE RENOVATIONS OF THE RESTROOM FACILITIES AT POKAI BAY.

WHEREAS, Pokai Bay is one of the most-visited ocean areas 1 2 on Oahu's Leeward Coast because of its wide sandy beach and relatively calm waters; and 3 4 WHEREAS, because it is protected by an offshore breakwater, 5 Pokai Bay maintains calm conditions year-round, which makes it 6 an ideal location for many ocean users, including swimmers, 7 canoe paddlers, surfers, snorkelers, boaters, divers, and stand-8 up paddlers; and 9 10 WHEREAS, despite Pokai Bay's pristine appearance of 11 crystal-blue waters and white sand, it is sadly the site of 12 pollution from multiple sources, including runoff from 13 surrounding surfaces, illegal dumping, and user-induced 14 contaminants; and 15 16 WHEREAS, over the last decade, beach users and local 17 18 community members have reported the presence of health and environmental hazards at Pokai Bay; and 19 20 WHEREAS, additional suspected sources of pollution at Pokai 21 Bay include water runoff containing industrial pollutants washed 22 from local surface streets, parking lots, and sidewalks; 23 illegally moored boats; and petrochemical-based pollutants from 24 vehicular use of an adjacent boat ramp; and 25 26 WHEREAS, historically, illegal dumping of dredging 27 materials and other substances has occurred at higher rates 28

1 along the Leeward Coast, including at Pokai Bay, than at other 2 locations on Oahu; and 3 WHEREAS, the significant use of Leeward Coast beaches for 4 camping and associated activities of daily life by homeless 5 persons, such as bathing, are suspected to have introduced 6 higher than normal levels of bacteria to the sand and waters at 7 Pokai Bay, resulting in a rash of staph infections and other 8 9 health problems among regular beach users; and 10 WHEREAS, a 2015 study by professors and researchers at the 11 University of Hawaii at Manoa's Department of Civil and 12 Environmental Engineering found that beach sand holds more fecal 13 indicator bacteria than seawater; and 14 15 WHEREAS, based upon the results of this study, the beach 16 sand at Pokai Bay may be found to retain pollutants from the 17 18 restroom facilities in the area, specifically rinse-off from the showers and fecal bacteria from toilet plumbing; and 19 20 WHEREAS, the Department of Health has the supplies to test 21 22 seawater and occasionally tests the seawater in Pokai Bay specifically for fecal indicator bacteria, which decays at 23 24 slower rates in the beach sand than in seawater; now, therefore, 25 26 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 27 28 Session of 2023, the Senate concurring, that the Department of 29 Health is urged to prioritize testing and research of fecal indicator bacteria levels and any other pollutants of the beach 30 sand at Pokai Bay; and 31 32 BE IT FURTHER RESOLVED that the Department of Health is 33 34 urged to make testing and research of fecal indicator bacteria levels and any other pollutants in beach sand at Pokai Bay a 35 36 priority of the Department's non-point source pollution program; 37 and 38 BE IT FURTHER RESOLVED that the Department of Health is 39 urged to develop a plan to increase water circulation at Pokai 40 Bay to improve water quality and mitigate environmental and 41

health risks caused by pollution and contaminants in the water; 1 2 and 3 4 BE IT FURTHER RESOLVED that the Department of Health is requested to collaborate with other appropriate state and county 5 agencies to develop the plan to increase water circulation; and 6 7 8 BE IT FURTHER RESOLVED that the Department of Health is requested to submit a report of its collaborative activities, 9 10 including significant findings, cost estimates, and any proposed legislation to increase water circulation at Pokai Bay, to the 11 Legislature no later than twenty days prior to the convening of 12 the Regular Session of 2024; and 13 14 BE IT FURTHER RESOLVED that based upon the Department of 15 Health's testing and research of fecal indicator bacteria in the 16 beach sand at Pokai Bay, the City and County of Honolulu 17 Department of Parks and Recreation is requested to prioritize 18 19 renovations of the restroom facilities at Pokai Bay; and 20 BE IT FURTHER RESOLVED that certified copies of this 21 Concurrent Resolution be transmitted to the Director of Health 22 and Director of the City and County of Honolulu Department of 23 Parks and Recreation. 24 25 26 27
