HOUSE RESOLUTION

URGING THE PUBLIC UTILITIES COMMISSION TO REEVALUATE AND ADOPT ADMINISTRATIVE RULES RELATING TO THE REMOVAL OF ABANDONED OR DOUBLE UTILITY POLES, LINES, AND EQUIPMENT.

WHEREAS, the Public Utilities Commission regulates all 1 chartered, franchised, certificated, and registered public 2 utility companies operating in the State; and 3 4 WHEREAS, the Public Utilities Commission's administrative 5 rules adopted the 2002 edition of the National Electrical Safety 6 Code as it pertains to the installation, operation, and 7 maintenance of overhead and underground electrical supply and 8 9 communication lines; and 10 WHEREAS, the 2002 edition of the National Electrical Safety 11 12 Code states that "[1] ines and equipment permanently abandoned shall be removed or maintained in a safe condition"; and 13 14 WHEREAS, Hawaiian Electric Company, Inc. (Hawaiian 15 Electric) is a utility company in the State that provides 16 electric services via lines using wooden poles within existing 17 county and state street rights-of-way to residential communities 18 19 and businesses; and 20 21 WHEREAS, Hawaiian Electric owns over 120,000 utility poles on the island of Oahu; and 22 23 24 WHEREAS, when a new utility pole is installed adjacent to an existing utility pole for the purpose of transferring 25 26 electric, telephone, cable, or other wires from one pole to 27 another, the original pole is often left in place, resulting in what is referred to as double poles; and 28 29 WHEREAS, there are thousands of derelict utility poles, 30 31 double poles, and utility lines abandoned across Hawaii 32 neighborhoods; and

1 WHEREAS, the derelict utility and communication lines, 2 3 abandoned utility poles, and redundant double poles should be 4 removed in a timely manner due to their growing threat to public safety; and 5 6 WHEREAS, the removal of unnecessary and unsightly derelict 7 8 lines and poles will eliminate a potential public hazard, 9 organize communication and utility pole lines, and favorably 10 influence the surrounding community; now, therefore, 11 12 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 13 Session of 2023, that the Public Utilities Commission is urged 14 to reevaluate and adopt administrative rules relating to the 15 removal of abandoned lines, double poles, and equipment; and 16 17 18 BE IT FURTHER RESOLVED that the Public Utilities Commission 19 is requested to adopt updated provisions of the National Electrical Safety Code to streamline the removal of double poles 20 and other unsafe abandoned equipment; and 21 22 23 BE IT FURTHER RESOLVED that certified copies of this 24 Resolution be transmitted to the Commissioners of the Public Utilities Commission and President and Chief Executive Officer 25 of the Hawaiian Electric Company, Inc. 26 27 28 OFFERED BY: July 29
