HOUSE RESOLUTION

REQUESTING THE OFFICE OF COLLECTIVE BARGAINING TO ESTABLISH OBJECTIVE STANDARDS AND CRITERIA FOR SPLITTING OFF A GROUP OF STATE WORKERS INTO A NEW BARGAINING UNIT.

1 WHEREAS, the National Labor Relations Act, title 29 United 2 States Code sections 151-169 (Act), declares that the policy of the United States is to be carried out "by encouraging the 3 practice and procedure of collective bargaining and by 4 5 protecting the exercise by workers of full freedom of association, self-organization, and designation of 6 representatives of their own choosing, for the purpose of 7 8 negotiating the terms and conditions of their employment or other mutual aid or protection"; and 9 10

WHEREAS, under the Act a unit of employees is a group of two or more employees who share a community of interest and may reasonably be grouped together for purposes of collective bargaining; the determination of what is an appropriate unit for these purposes is, under the Act, left to the discretion of the National Labor Relations Board (Board); and

18 WHEREAS, this broad discretion is limited by several other 19 provisions of the Act, including the Board's inability to 20 approve as appropriate a unit that includes both professional 21 and nonprofessional employees, unless a majority of the 22 professional employees involved vote to be included in the mixed 23 unit; and

WHEREAS, under the Act, the appropriateness of a bargaining unit is generally determined on the basis of a community of interest of the employees involved, where, among other factors, those who have the same or substantially similar interests concerning wages, hours, and working conditions are grouped together in a bargaining unit; and

WHEREAS, section 89-6, Hawaii Revised Statutes, recognizes 1 fifteen bargaining units and also lists categories of 2 individuals who shall not be included in any appropriate 3 bargaining unit or be entitled to coverage under that chapter; 4 5 and 6 7 WHEREAS, this body continues to consider measures 8 requesting that additional bargaining units be established but lacks objective standards and criteria to evaluate whether a new 9 10 bargaining unit is appropriate; and 11 12 WHEREAS, the creation of a new bargaining unit has 13 significant impacts for not only the employees receiving the 14 benefit of collective bargaining, but also the employer who must then negotiate on subjects including wages, hours, conditions of 15 16 employment, and benefits; and 17 18 WHEREAS, the protection of fair working conditions and 19 workers' rights are important topics that should not be 20 addressed in a haphazard manner but with the benefit of standards and criteria that can be applied without bias; now, 21 therefore, 22 23 24 BE IT RESOLVED by the House of Representatives of the 25 Thirty-second Legislature of the State of Hawaii, Regular 26 Session of 2023, that the Office of Collective Bargaining is 27 requested to establish objective standards and criteria for 28 splitting off a group of state workers into a new bargaining unit to assist the Legislature in determining the 29 appropriateness of requests that come before it; and 30 31 32 BE IT FURTHER RESOLVED that the Office of Collective 33 Bargaining is requested to submit a report of its findings and 34 recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of 35 36 the Regular Session of 2024; and 37 38 BE IT FURTHER RESOLVED that certified copies of this 39 Resolution be transmitted to the Governor and Chief Negotiator 40 of the Office of Collective Bargaining. 41 42
