A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART 1
2	SECTION 1. There is appropriated out of the general
3	revenues of the State of Hawaii the sum of \$ or so much
4	thereof as may be necessary for fiscal year 2023-2024 and the
5	same sum or so much thereof as may be necessary for fiscal year
6	2024-2025 to be deposited into the preschool open doors special
7	fund.
8	SECTION 2. There is appropriated out of the preschool open
9	doors special fund the sum of \$ or so much thereof as
10	may be necessary for fiscal year 2023-2024 and the same sum or
11	so much thereof as may be necessary for fiscal year 2024-2025
12	for the preschool grant program, the hiring of three temporary
13	information technology positions without regard to chapter 89,
14	Hawaii Revised Statutes, to support modifications to the
15	preschool open doors program, and the data governance issues
16	necessitated by Act 46, Session Laws of Hawaii 2020, and Act
17	210 Session Laws of Hawaii 2021 Funds appropriated nursuant

- 1 to this section may also be expended on additional permanent
- 2 staff, benefit expenses related to the new staff, and costs
- 3 associated with necessary modifications to the preschool open
- 4 doors program. Funds appropriated pursuant to this section may
