A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. There is appropriated out of the general
3	revenues of the State of Hawaii the sum of \$ or so
4	much thereof as may be necessary for fiscal year 2023-2024 and
5	the same sum or so much thereof as may be necessary for fiscal
6	year 2024-2025 to be deposited into the preschool open doors
7	special fund.
8	SECTION 2. There is appropriated out of the preschool open
9	doors special fund the sum of \$ or so much thereof as
10	may be necessary for fiscal year 2023-2024 and the same sum or
11	so much thereof as may be necessary for fiscal year 2024-2025
12	for the:
13	(1) Preschool grant program;
14	(2) Hiring of three temporary information technology
15	positions without regard to chapter 89, Hawaii Revised
16	Statutes, to support modifications to the preschool
17	open doors program; and

1 (3) Data governance issues necessitated by Act 46, Session 2 Laws of Hawaii 2020, and Act 210, Session Laws of 3 Hawaii 2021; 4 provided that funds appropriated pursuant to this section may 5 also be expended on additional permanent staff, benefit expenses related to the new staff, and costs associated with necessary 6 7 modifications to the preschool open doors program; provided 8 further that funds appropriated pursuant to this section may be 9 expended without regard to chapters 103D and 103F, Hawaii 10 Revised Statutes, as the case may be. 11 The sums appropriated shall be expended by the department 12 of human services for the purposes of this Act. 13 PART II SECTION 3. Section 346-184, Hawaii Revised Statutes, is 14 15 amended by amending subsection (b) to read as follows: 16 "(b) Accreditation under this section shall be obtained 17 from one or more of the following national early learning 18 accrediting organizations: 19 (1) National Association for the Education of Young

7	out the purposes of this section without regard to chapter 91 or
8	201M; provided that:
9	(1) The department shall hold at least one public hearing
10	prior to the adoption of interim rules;
11	(2) The interim rules shall comply with all applicable
12	state and federal laws; and
13	(3) The interim rules shall be effective for no more than
14	one year after their adoption."
15	SECTION 6. Section 346-182, Hawaii Revised Statutes, is
16	amended by amending subsection (a) to read as follows:
17	"(a) There is established within the state treasury the
18	preschool open doors special fund, to be administered by the
19	department's child care assistance program, into which shall be
20	deposited all moneys received by the department's child care
21	assistance program in the form of:

Act 210, Session Laws of Hawaii 2021, is 14 amended by amending section 14 to read as follows: 15 "SECTION 14. This Act shall take effect upon its approval; 16 provided that: 17 (1)Section 5 shall be repealed on July 1, 2022, and 18 section 302L-7, Hawaii Revised Statutes, shall be 19 reenacted in the form in which it read on the day

prior to the effective date of this Act;

Preschool Open Doors; Accreditation; Executive Office on Early Learning; Appropriation

Description:

Appropriates funds for the preschool open doors program and executive office on early learning to expand access to preschool and to implement program changes required by previous acts. Requires DHS to provide reimbursements to providers participating in the preschool open doors program and adjust the reimbursement rates at least once every two years. Expands the types of entities from which a preschool open doors service provider may obtain accreditation. Expands the preschool open doors program and public prekindergarten program application process to eligible three-year-old children. Authorizes the preschool open doors special fund to accept federal funds. Effective 6/30/3000. (HD2)
