# A BILL FOR AN ACT

RELATING TO BEACHES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 226-11, Hawaii Revised Statutes, is
2	amended by	y amending subsection (b) to read as follows:
3	"(b)	To achieve the land-based, shoreline, and marine
4	resources	objectives, it shall be the policy of this State to:
5	(1)	Exercise an overall conservation ethic in the use of
6		Hawaii's natural resources.
7	(2)	Ensure compatibility between land-based and
8		water-based activities and natural resources and
9		ecological systems.
10	(3)	Take into account the physical attributes of areas
11		when planning and designing activities and facilities.
12	(4)	Manage natural resources and environs to encourage
13		their beneficial and multiple use without generating
14		costly or irreparable environmental damage.
15	(5)	Consider multiple uses in watershed areas $[\tau]$ ; provided
16		[such] that the uses do not detrimentally affect water
17		quality and recharge functions.

1	(6)	Encourage the protection of rare or endangered plant
2		and animal species and habitats native to Hawaii.
3	(7)	Provide public incentives that encourage private
4		actions to protect significant natural resources from
5		degradation or unnecessary depletion.
6	(8)	Pursue compatible relationships among activities,
7		facilities, Native Hawaiian traditional practices
8		mauka and makai, and natural resources.
9	(9)	Promote increased accessibility and prudent use of
10		inland and shoreline areas for public recreational,
11		educational, and scientific purposes.
12	(10)	Promote statewide beach assessments and beach and
13		shoreline adaptation, restoration, and conservation to
14		develop feasible beach and shoreline adaptation,
15		restoration, or conservation options."
