## A BILL FOR AN ACT

RELATING TO THE RENEWAL OF DRIVER'S LICENSES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-107, Hawaii Revised Statutes, is
- 2 amended as follows:

- 4 "(c) Any person who holds a category (1), (2), or (3)
- 5 license issued under this part [who is unable to-appear in
- 6 person before the examiner of drivers to apply for a renewal of

- 8 online via any electronic or digital means provided by the
- 9 examiner of drivers, or by mail, if the person is not
- 10 disqualified from renewing the license under subsection (a)
- 11 except as provided under subsection (h) [, apply for a renewal by
- 12 mail]. The applicant's request to have the license renewed by
- 13 mail must be received by the examiner of drivers within ninety
- 14 days after the expiration of the license or it shall be treated
- 15 as an application for reactivation of an expired license under
- 16 section 286-107.5. The examiner of drivers shall, upon receipt
- 17 of the request, furnish the applicant with all necessary forms



1	and instructions. An application for renewal made by mail or by
2	electronic or digital means pursuant to this subsection shall be
3	accompanied by a statement from a licensed physician, physician
4	assistant, or advanced practice registered nurse certifying that
5	the applicant was examined by the licensed physician, physician
6	assistant, or advanced practice registered nurse not more than
7	six months [prior to] before the expiration date of the
8	applicant's license and that the applicant was found by the
9	examination to have met the physical requirements established by
10	the state director of transportation for the renewal of
11	licenses. The application for renewal by mail or by electronic
12	or digital means shall also be accompanied by:
13	(1) A notarized statement of the applicant certifying that
14	the applicant does not possess any valid license to
15	operate the same or similar category or categories of
16	motor vehicles, issued by another licensing authority
17	(unless the license is concurrently surrendered); and
18	(2) [Such] Any other information as may be required by the
19	examiner of drivers that is reasonably necessary to
20	confirm the identity of the applicant and the
