A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that it is a matter of
statewide concern that the president of the University of Hawaii
serves simultaneously as the chief procurement officer for the
University of Hawaii system. The president of the system
simultaneously serving as the chief procurement officer leads to
inevitable conflicts of interest.

7 The legislature further finds that across the United 8 States, the vast majority of public higher education 9 institutions, including the California State University System, 10 University of Massachusetts System, and University of Oregon 11 System, differentiate between institutional leadership and 12 purchasing when assigning the authority over procurement. While 13 the chief procurement officer for the Colorado State University 14 System possesses authority over state purchasing and procurement 15 as well as direct oversight over Colorado's institutions of 16 higher learning, there were no instances in institutions across

1 the country in which a university president is concurrently 2 named as chief procurement officer. 3 Accordingly, the purpose of this Act is to designate the vice president for budget and finance and chief financial 4 officer as the chief procurement officer for the University of 5 6 Hawaii. 7 SECTION 2. Section 103D-203, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 8 9 "(a) The chief procurement officer for each of the 10 following state entities shall be: 11 (1) The judiciary--the administrative director of the 12 courts; 13 (2) The senate--the president of the senate; 14 (3) The house of representatives -- the speaker of the house 15 of representatives; 16 (4) The office of Hawaiian affairs--the chairperson of the 17 board; 18 (5) The University of Hawaii -- [the-president of the 19 University of Hawaii;] the vice president for budget and finance and chief financial officer; 20
