A BILL FOR AN ACT

RELATING TO COMMERCIAL OCEAN RECREATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that many tourists who
- 2 visit the State participate in watersports, such as snorkeling,
- 3 scuba diving, kayaking, and surfing. There are companies that
- 4 conduct commercial operations that take customers on excursions
- 5 in state waters for the purpose of engaging in recreation
- 6 activities. These commercial operations are required to obtain
- 7 a permit from the department of land and natural resources
- 8 division of boating and ocean recreation. However, the
- 9 provisions for obtaining those permits do not include safety
- 10 requirements, which leads to potential consumer safety issues.
- 11. The legislature further finds that the number of visitors
- 12 coming to Hawaii continues to grow and locations for commercial
- 13 ocean recreation are more heavily used with each passing year.
- 14 This has led to an increase in safety-related incidents over
- 15 time, including a fatal boating accident off the coast of
- 16 Kailua-Kona in April of 2022. More stringent crew training
- 17 requirements would both increase safety and ensure that

- 1 companies engaging in commercial tours have to meet some minimum
- 2 requirements before charging customers.
- 3 The legislature also finds that House Concurrent Resolution
- 4 No. 86, H.D. 1, S.D. 1, adopted in 2015, requested the
- 5 department of land and natural resources to engage stakeholders
- 6 to consider adopting permitting provisions requiring employees
- 7 of companies who take customers on watersport excursions to be
- 8 trained in basic water safety measures. However, the
- 9 legislature finds that the department of land and natural
- 10 resources has not taken action in response to the provisions of
- 11 the concurrent resolution.
- 12 The purpose of this Act is to increase customer safety by
- 13 requiring:
- 14 (1) Commercial ocean operators who take customers into
- 15 state waters to engage in recreational activities such
- as snorkeling, scuba diving, kayaking, and surfing
- 17 lessons, to have at least one individual aboard the
- 18 vessel who is certified as a rescue diver or lifeguard
- by a nationally recognized certification organization;

| 6 | SECTION 2. Chapter 200, Hawaii Revised Statutes, is |
| 7 | amended by adding a new section to part II to be appropriately |
| 8 | designated and to read as follows: |
| 9 | "§200- Commercial ocean operator; crew and safety |
| 10 | requirements. (a) Each commercial ocean operator who |
| 11 | transports customers aboard a vessel into state waters to engage |
| 12 | in recreational activities, including snorkeling, scuba diving, |
| 13 | kayaking, and surfing, shall have aboard the vessel used to |
| 14 | transport the customers at least one individual who is certified |
| 15 | as a rescue diver or lifeguard by a nationally recognized |
| 16 | certification organization; provided that this subsection shall |
| 17 | not apply to vessels having a valid vessel safety check issued |
| 18 | by the United States Coast Guard Auxiliary and that have at |
| 19 | least one individual aboard the vessel who is lifeguard |
| 20 | certified in cardio pulmonary resuscitation, use of an automated |
| 21 | external defibrillator, and basic first aid. |

Report Title:

Boating Law; Commercial Ocean Operators; Vessels; Safety

Description:

Requires commercial ocean operators who take customers into state waters to engage in recreational activities to have at least one individual aboard the vessel who is rescue diver or lifeguard certified by a nationally recognized certification organization. Requires vessels that transport customers for the purpose of engaging in an activity in state waters to have a backboard, emergency oxygen, and an automated external defibrillator included in its onboard safety equipment.
