A BILL FOR AN ACT

RELATING TO EDUCATIONAL HEALTH SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. All medication requests to be administered by 2 school health assistants are currently reviewed and must be 3 approved by Hawaii department of health public health nurses. 4 This process ensures that a health care professional has 5 reviewed the medication request and determined that it is safe 6 and appropriate for a student to receive treatment. For 7 example, some medications would be best administered before or 8 after school and other medications may not be allowed if a 9 school health assistant is not qualified to assess the need for 10 as-needed medication. Medication administration is part of the 11 medication management process and requires clinical supervision 12 by a health care professional, including a registered nurse, 13 advanced practice registered nurse, physician assistant, or 14 physician, to ensure the health and safety of students if 15 unlicensed assistive personnel, such as school health 16 assistants, are utilized. 17 Some schools have a registered nurse, advanced practice

registered nurse, or other specialized health care provider on

1 campus through written agreements with the department of 2 education. Partnerships with federally qualified health centers 3 and the University of Hawaii at Manoa school of nursing have 4 greatly improved access to health services for students at 5 school and through telehealth. Student care would be more 6 efficient, accessible, and safe if the administration of the 7 medication could be performed with the approval of a health care 8 professional within the department of education, department of 9 health, or a health care service per a written agreement with 10 the department of education. The current law prevents health 11 care professionals who are already on campus or in the school 12 community from performing the function of medication approval. 13 The purpose of this Act is to allow administration of 14 medications by school health assistants at school with the 15 approval of a health care professional within the department of 16 education, department of health, or health care service per a 17 written agreement with the department of education. This Act 18 amends statutes to match the existing department of education 19 practice for administration of medication at schools. This Act 20 also updates the term "school health aides" to "school health 21 assistants" to reflect updated job titles at the department of 22 education.

SECTION 2. Section 302A-708, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "[+] §302A-708 Career development opportunities.[+] The 4 department of education shall provide career pathways development and training opportunities to all school health 5 [aides] assistants in the school health services field and other 6 fields within the department of education to ensure the 7 8 opportunity for continued employment with the department of 9 education." 10 SECTION 3. Section 302A-853, Hawaii Revised Statutes, is 11 amended to read as follows: 12 "§302A-853 Administration of medication. (a) School 13 health [aides] assistants may assist students by administering 14 oral and topical medication, and in emergency situations, other 15 premeasured medication; provided that: 16 If the student receiving the medication is a minor, a (1)parent or guardian requests and authorizes the 17 administration of medication; 18 The medication has been prescribed by a licensed 19 (2) physician, as defined in section 334-1, or by a 20 practitioner with prescriptive authority; 21

1	(3)	The administration of the medication is with the	
2		approval of [the department of health; and] a health	
3		care professional within the department of education,	
4		department of health, or health care service as	
5		defined in section 323D-2 per a written agreement with	
6		the department of education; and	
7	(4)	The administration of the medication is necessary for	
8		the health of the student and for the student's	
9		attendance at school.	
10	(b)	For purposes of this section, "health care	
11	professional" means physicians, surgeons, and others licensed		
12	pursuant to chapter 453 and nurses licensed pursuant to chapter		
13	<u>457.</u> "		
14	SECTION 4. Section 302A-854, Hawaii Revised Statutes, is		
15	amended to read as follows:		
16	"§302A-854 School health [aides;] assistants;		
17	compensation. All full-time school health [aides] assistants		
18	employed in the department shall be employed and have their		
19	compensation fixed in accordance with chapter 76 and the		
20	appropriate collective bargaining agreement, executive order,		
21	executive directive, or rule."		

1	SECTI	ON 5. Section 457-13, Hawaii Revised Statutes, is
2	amended to	read as follows:
3	"§457	7-13 Exceptions. This chapter does not prohibit:
4	(1)	The furnishing of nursing assistance in an emergency;
5	(2)	The practice of nursing that is incidental to the
6		program of study engaged in by students enrolled in
7		nursing education programs accredited by the board;
8	(3)	The practice of nursing under a nonrenewable permit
9		by:
10		(A) A graduate of; or
11		(B) An applicant who has provided proof that the
12		applicant has completed the entire educational
13		curriculum required for graduation for a nursing
14		license from,
15		a school that is in or under the jurisdiction of the
16		United States, a territory, or a foreign jurisdiction,
17		and whose accreditation is recognized by the board;
18		provided that following completion of (A) or (B), the
19		candidate takes the first licensing examination
20		scheduled by any board of nursing recognized by the
21		board and has submitted to the board an application
22		for a license to practice nursing in the State; and

1		provided further that the permit shall be valid for
2		three months or until the results of the licensing
3		examination are received by the board;
4	(4)	The practice of any legally qualified nurse of another
5		state who is employed by the United States or any
6		bureau, division, or agency thereof, while in the
7		discharge of the nurse's official duties;
8	(5)	The practice of nursing in connection with healing by
9		prayer or spiritual means alone in accordance with the
10		tenets and practice of any well recognized church or
11		religious denomination, provided that no person
.12		practicing such nursing claims to practice as a
13		registered nurse or a licensed practical nurse; or
14	(6)	The administration of oral and topical medication and
15		in emergency situations, other premeasured medication,
16		by school health [aides as provided in section 302A-
17		853.] assistants."

PURPOSE: Allows the administration of medication to

public school students by health assistants

with the approval of a health care professional within the Department of

Education, Department of Health, or a health care service per a written agreement with the Department of Education. Replaces the term "school health aides" with "school health assistants" to reflect recent changes

to the job title.

MEANS: Amends sections 302A-708, 302A-853, 302A-

854, and 457-13, Hawaii Revised Statutes.

JUSTIFICATION: Under current law, all medication requests

to be administered by school health

assistants are currently reviewed and must be approved by Hawaii Department of Health public health nurses. This process ensures that a health care professional has reviewed the medication request and determined that it is safe and appropriate for a student to receive treatment. For example, some medications would be best administered before or after school and other medications may not be allowed if a school health assistant is not qualified to assess the

need for as-needed medication. Medication administration is part of the medication management process and requires clinical supervision by a health care professional, including a registered nurse, advanced practice registered nurse, physician assistant, or physician, to ensure the health and safety of students if unlicensed

assistive personnel, such as school health

assistants, are utilized.

Some schools have a registered nurse, advanced practice registered nurse, or other

specialized health care provider on campus through written agreements with the Department of Education. Partnerships with federally qualified health centers and the University of Hawaii at Manoa School of Nursing have greatly improved access to health services for students at school and through telehealth. Student care would be more efficient, accessible, and safe if the administration of the medication could be performed with the approval of a health care professional within the Department of Education, Department of Health, or a health care service per a written agreement with the Department of Education. The current law prevents health care professionals who are already on campus or in the school community from performing the function of medication administration approval.

Replaces the term "school health aides" with "school health assistants" to reflect recent changes to the job title.

Impact on the public: More efficient
student care.

Impact on the department and other agencies:
The Department of Education will have more staff that can approve administration of medication to students in a more timely manner. The Department of Health approves medication requests. Partnerships with federally qualified health centers and the University of Hawaii at Manoa School of Nursing have greatly improved access to health services for students at school and through telehealth.
