A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING ON HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that affordable housing
- 2 credits have been utilized by the department of Hawaiian home
- 3 lands to provide affordable housing opportunities for its
- 4 beneficiaries at no cost to the State. This program allowed for
- 5 the purchase of additional land in a location that beneficiaries
- 6 were interested in but where the department had no land in the
- 7 area, and resulted in a reduction in the price of housing units
- 8 offered by homebuilders on Hawaiians home lands.
- 9 The purpose of this Act is to make permanent the affordable
- 10 housing credit program for the department of Hawaiian home
- 11 lands.
- 12 SECTION 2. Act 141, Session Laws of Hawaii 2009, as
- 13 amended by section 3 of Act 102, Session Laws of Hawaii 2015, as
- 14 amended by section 1 of Act 80, Session Laws of Hawaii 2019, is

- 17 provided that on July 1, 2024, this Act shall be repealed and

- 8 by amending section 3 to read as follows:

- 14 SECTION 4. Statutory material to be repealed is bracketed
- 15 and stricken.
- 16 SECTION 5. This Act shall take effect upon its approval.

Description:

Makes permanent Act 141, Session Laws of Hawaii 2009, which requires the counties to issue affordable housing credits to the Department of Hawaiian Home Lands upon the Department's request. Makes permanent Act 98, Session Laws of Hawaii 2012, which requires the counties to issue affordable housing credits for each residential unit developed by the Department of Hawaiian Home Lands.
