### A BILL FOR AN ACT

RELATING TO THE EXECUTIVE OFFICE ON AGING ADMINISTRATIVE CLAIMING SPECIAL FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to clarify the 2 allowable revenues to be deposited into the executive office on 3 aging administrative claiming special fund. SECTION 2. Section 349-5.5, Hawaii Revised Statutes, is 4 5 amended to read as follows: "[+]§349-5.5[+] Executive office on aging administrative 6 (a) There is established in the state 7 claiming special fund. 8 treasury the executive office on aging administrative claiming 9 special fund into which shall be deposited:
- 10 All revenues from medicaid administrative claiming (1) 11 designated for the department of health that are 12 allowable for operating the aging and disability 13 resource centers[+] and programs within the executive 14 office of aging;
- 15 (2) Appropriations made by the legislature to the fund; 16 and
- Grants and gifts made to the fund. **17** (3)
