## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291-14, Hawaii Revised Statutes, is amended as follows: 2 (1) By amending subsection (a) to read as follows: 3 "(a) No person shall stand in the bed or load-carrying 4 5 area of any motor vehicle commonly known as a pickup truck while the vehicle is in operation. No operator of any pickup truck 6 shall operate the vehicle with a passenger seated in the bed or 7 load-carrying area of the vehicle [unless: 8 9 (1) There is no seating available in the cab of the 10 vehicle: (2) The side racks of the vehicle are securely attached 11 and the tailboard or tailgate is securely closed; 12 (3) Every passenger in the bed or load carrying area of 13 the vehicle is seated on the floor and does not 14 15 attempt to control unlashed cargo.] 16 except under subsection (c)." By amending subsections (c) and (d) to read as 17 18 follows:

1	"(c) No operator of any pickup truck may operate the
2	vehicle with any passenger [twelve years of age or under] in the
3	bed or load-carrying area of the vehicle, unless one of the
4	following applies:
5	(1) An emergency exists that threatens the life of the
6	passenger being transported in the bed or load-
7	carrying area of the vehicle; or
8	(2) The vehicle is being operated in parades, caravans, or
9	exhibitions [which] that are officially authorized or
10	otherwise permitted by law.
11	(d) Any person who violates this section shall be subject
12	to a fine of \$25 for each violation[, provided that any person
13	who violates subsection (c) shall be subject to a fine of \$50
14	for each separate violation]."
15	SECTION 2. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 3. This Act shall take effect upon its approval.

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO TRUCK BEDS.

PURPOSE: To repeal several exemptions from the

prohibition on operating a pickup truck with

a passenger seated in the bed or load—

carrying area, including the exemption that allows passengers over twelve years of age to

ride in the bed or load-carrying area.

MEANS: Amend section 291-14(a), (c), and (d), Hawaii

Revised Statutes.

JUSTIFICATION: Cargo areas of motor vehicles with beds,

commonly known as pickup trucks, are not designed to transport occupants. When

involved in a crash an occupant seated in the cargo area of a pickup truck can be thrown from the bed of the pickup truck and sustain

serious injuries or worse.

According to Fatal Analysis Reporting System,

from 2015 through 2019, there were two roadway crashes that resulted in four

fatalities on our roadways due to the victims

riding in the bed of a truck.
