## A BILL FOR AN ACT

RELATING TO HEALTH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The department of health and department of human services shall develop and adopt rules, policies, and plan amendments necessary to ensure that the state medicaid program covers medically necessary services, including applied behavior analysis services, for individuals aged twenty-one and older with neurodevelopmental disorders, including autism spectrum disorder.

8 SECTION 2. The department of health and department of 9 human services shall apply for any necessary approvals from the 10 Centers for Medicare and Medicaid Services to amend the state 11 medicaid plan to provide reimbursements for medically necessary 12 services, including applied behavior analysis services to 13 medicaid-eligible persons over the age of twenty-one diagnosed 14 with autism spectrum disorder.

15 SECTION 3. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so 17 much thereof as may be necessary for fiscal year 2023-2024 and
