A BILL FOR AN ACT

RELATING TO A MODERN HAWAII HISTORY MUSEUM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has a rich
- 2 history captured for posterity by numerous institutions. Among
- 3 these are the Bernice Pauahi Bishop Museum, also known as the
- 4 State Museum of Natural and Cultural History, which has a
- 5 primary focus on early Hawaiian history, navigation, and
- 6 science; Iolani Palace, which provides a primary focus on the
- 7 Hawaiian monarchy and overthrow era, the King Kamehameha
- 8 Judiciary History Center, which has a primary focus on educating
- 9 the public on the judicial process and Hawaii's legal history;
- 10 and the State Archives, which has a vast catalogue of historical
- 11 artifacts and history such as copies of the Hawaii State
- 12 Constitution and moon rocks, but no meaningful place to properly
- 13 exhibit them and tell their story.
- 14 The legislature further finds that through the territorial
- 15 period and statehood to present day, Hawaii played a significant
- 16 role contributing to national and global events and progress.
- 17 This includes growing as a model of social integration as the

- 1 nation's first majority-minority state, which the Reverend
- 2 Martin Luther King, Jr. called, "a place where we see the
- 3 glowing daybreak of freedom and dignity and racial justice". It
- 4 includes the local and national contributions of Hawaii's
- 5 greatest generation of leaders growing out of the World War II
- 6 era, who broke conventional norms and influenced the course of
- 7 the nation; achieving world renowned modern discoveries in ocean
- 8 science and astronomy, and developing a modern renaissance in
- 9 music and arts that has influenced the world; and Hawaii's role
- 10 frequently driving political progress in the United States as
- 11 the birthplace of Title IX, legal abortion, widely accessible
- 12 health care, same sex marriage, and most recently leadership on
- 13 climate change, including groundbreaking one hundred percent
- 14 clean energy and carbon negative economy policies now being
- 15 replicated around the country.
- Accordingly, the purpose of this Act is to:
- 17 (1) Establish a museum of modern Hawaii history;
- 18 (2) Convene a task force to further develop plans for the
- establishment, construction, and operation of a museum
- of modern Hawaii history; and
- 21 (3) Appropriate funds for the purposes of this Act.

1	SECTION 2. Chapter 9, Hawaii Revised Statutes, is amended		
2	by adding	a new part to be appropriately designated and to read	
3	as follow	s:

5	§9-	Museum of modern Hawaii history; established. (a)	
6	There is	established within the foundation the museum of modern

8	(b)	The museum of modern Hawaii history shall:	
9	(1)	Primarily focus on the territorial and statehood eras	
10		of the Hawaii's history, and serve as a compliment to	
11		other institutions;	
12	(2)	Chronicle Hawaii's significant milestones and events	
13		in its history as well as the leadership that the	
14		State has demonstrated with respect to many	
15		significant issues facing the nation and the world;	
16	(3)	Provide a window into current events and issues; and	
17	(4)	Partner with other institutions in Hawaii and abroad	
18		to share relevant narratives.	
19	(c)	The foundation may establish a nonprofit group or	
20	select a	nonprofit group with the demonstrated qualifications to	
21	manage an	d operate the museum of modern Hawaii history, its	

1 concessions, or other for-profit business enterprises in a 2 manner that is self-sustaining." 3 SECTION 3. (a) There is established a museum of modern 4 Hawaii history task force within the state foundation on culture 5 and the arts for administrative purposes to develop plans for the establishment, construction, and operations of a museum of 6 modern Hawaii history, and explore partnerships, collaborations, 7 or incorporating efforts with other local institutions with 8 9 different missions that may have some overlap, such as the state archives and King Kamehameha V judiciary history center. 10 The working group shall consist of the following 11 (b) 12 members: 13 The executive director of the state foundation on (1) 14 culture and the arts or their designee, who shall 15 serve as the chair; 16 (2) The president and chief executive officer of the 17 Hawaii tourism authority or their designee; The state archivist or their designee; 18 (3) 19 (4)A representative of the University of Hawaii; The chairs of the standing committees of the senate 20 (5)

21	revenues	of the State of Hawaii the sum of \$	or so	

- 1 much thereof as may be necessary for fiscal year 2023-2024 and
- 2 the same sum or so much thereof as may be necessary for fiscal
- 3 year 2024-2025 for the administration of the museum of modern
- 4 Hawaii history task force to carry out its duties.
- 5 The sums appropriated shall be expended by the state
- 6 foundation on culture and the arts for the purposes of this Act.
- 7 SECTION 5. This Act shall take effect on July 1, 2023.
