## A BILL FOR AN ACT

RELATING TO THE RESEARCH CORPORATION OF THE UNIVERSITY OF HAWAII.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the research
- 2 corporation of the University of Hawaii, a public
- 3 instrumentality of the State that is administratively attached
- 4 to the University of Hawaii, was established in 1965 for the
- 5 purposes of promoting, encouraging, initiating, developing, and
- 6 conducting scientific research and investigation in all branches
- 7 of learning and disseminating this research and investigation to
- 8 the public.
- 9 To promote cooperative research projects with private firms
- 10 and persons, the legislature at the time granted the research
- 11 corporation of the University of Hawaii flexibility in the
- 12 hiring of its personnel and handling and disbursement of moneys
- 13 by exempting the corporation from state laws relating to
- 14 reimbursement of special funds to the state general fund;
- 15 advertisement for bids and purchases to be made in Hawaii
- 16 whenever public moneys are expended; civil service;

- 1 compensation; and public employment. The legislature finds,
- 2 however, that it is a matter of statewide concern that the
- 3 research corporation of the University of Hawaii has gradually
- 4 expanded its undertakings over the years into areas beyond its
- 5 original eponymous purpose, and the benefits of the exemptions
- 6 from statutory requirements have been extended to apply beyond
- 7 what was originally intended by the legislature. For example,
- 8 the research corporation's website currently states that one of
- 9 its missions is to "support and enhance . . . development" in
- 10 Hawaii.
- 11 The purpose of this Act is to clarify that the purpose of
- 12 the research corporation of the University of Hawaii is to
- 13 promote educational, scientific, and literary pursuits through
- 14 research, training of research personnel, and dissemination of
- 15 knowledge by publication of research findings, and the
- 16 corporation's undertakings shall be limited to acts that are
- 17 reasonably necessary to carry out this purpose.
- 18 SECTION 2. Section 304A-112, Hawaii Revised Statutes, is
- 19 amended to read as follows:
- 20 "[+]\$304A-112[+] Contracts for services provided by the
- 21 research corporation of the University of Hawaii. (a)

- 1 Notwithstanding any law to the contrary, when the university
- 2 determines that neither the university nor another state agency
- 3 can more effectively or efficiently accomplish the purposes of
- 4 the sponsored research and training activities, the university
- 5 [shall] may contract with the research corporation of the
- 6 University of Hawaii established under section [+]304A-3001[+]
- 7 to provide management and other services as described in
- 8 subsection (b) to support the university's research and training
- 9 activities. Contracts by the university with the research
- 10 corporation pursuant to this section shall be limited to
- 11 sponsored research and training projects; except that
- 12 [university projects supported by] funds appropriated by the
- 13 legislature may [also] be [contracted] expended to contract with
- 14 the research corporation [pursuant to rules adopted by the board
- 15 of regents.] for purposes of supporting or facilitating
- 16 sponsored research and training activities.
- 17 (b) Management and other support services provided by the
- 18 research corporation pursuant to this section may include:
- 19 (1) The procurement of goods and services;
- 20 (2) Employment of personnel; and

The provision of advance funding for research and 1 2 training contracts and grants. These services may be provided by the corporation to the 3 4 university without regard to [chapter] chapters 76, 78, 89, [ex] 5 and 103D. 6 (c) For each state project or program involving the research corporation and each project or program involving the 7 8 research corporation and a state employee, the university shall 9 notify the exclusive representative of the appropriate 10 bargaining unit to review conformance of positions with 11 exceptions to collective bargaining. The corporation shall not 12 supplant civil service employees and shall obtain approval from 13 the governor on all initial requests for service projects." 14 SECTION 3. Section 304A-3001, Hawaii Revised Statutes, is 15 amended by amending subsection (b) to read as follows: 16 "(b) The purposes of the research corporation shall 17 [include, but not be limited to,] be the promotion of [all] 18 educational, scientific, and literary pursuits [by:] through 19 the: 20 (1) [Encouraging, initiating, aiding, developing, and

conducting training,] Conduct of research[, and study]

20		to promote these purposes in the interest of promoting
21		the general welfare of the people of the State.

3	SECT	ION 4. Section 304A-3003, Hawaii Revised Statutes, is
4	amended to	o read as follows:
5	"[+]	§304A-3003[ $+$ ] Powers of the research corporation. (a)
6	The resea	rch corporation, under the direction of the board of
7	directors	, shall have the following general powers:
8	(1)	To adopt, amend, and repeal bylaws governing the
9		conduct of its business and the exercise of the powers
10		and performance of duties granted to or imposed upon
11		it by law;
12	(2)	To sell, lease, rent, hold, maintain, use, and operate
13		any property, real, personal, or mixed, tangible or
14		intangible, in accordance with the conditions under
15		which it was received;
16	(3)	To enter into and perform [such] contracts, leases,
17		cooperative agreements, or other transactions with the
18		university or any other agency or political
19		subdivision of the State, any private person, firm,
20		partnership, association, company, or corporation,
21		only [as it may be] when the board of directors

determines that doing so is necessary in the conduct
of [its] the research corporation's business of
research, training of research personnel, and
publication of research findings, and only on [such]
terms [as it may deem] that the board of directors
deems reasonable and appropriate; provided that the
research corporation shall not obligate any funds of
the State except those that have been appropriated to
it.

Notwithstanding the foregoing, the research corporation may enter into and perform [such] contracts, leases, cooperative agreements, or other transactions with any agency or instrumentality of the United States, a foreign nation, a state, a territory, or a possession, or with any political subdivision thereof, for research, training of research personnel, or publication of research findings, whenever the donating or granting agency or instrumentality determines and documents that the university or any other agency of the State cannot [as effectively and efficiently] accomplish the purposes for which [such]

1		the contracts, leases, cooperative agreements, or
2		other transactions are being entered into; provided
3		that the research corporation shall not obligate any
4		funds of the State except those that have been
5		appropriated to it;
6	(4)	To receive by gifts, grants, devises, beguests, or

otherwise from private sources only, any property, real, personal, or mixed, intangible or tangible, absolutely or in trust, to be used and disposed of, either the principal or the income therefrom, in accordance with the conditions under which it was received; [except] provided that no gift to the research corporation shall be accepted unless approved [or confirmed] by the board of directors[-] as a gift that is beneficial to the research corporation's business of research, training of research personnel, and publication of research findings.

Notwithstanding the foregoing, the research corporation may receive gifts, grants, or awards from any agency or instrumentality of the United States, a foreign nation, a state, a territory, or a possession,

1		or from any political subdivision thereof, whenever
2		the donating or granting agency or instrumentality
3		determines and documents that the university or any
4		other agency of the State cannot [as effectively and
5		efficiently] accomplish the purposes for which the
6		gifts, grants, or awards are being made[, except];
7	,	provided that no gift to the research corporation
8		shall be accepted unless approved [or confirmed] by
9		the board of directors[+] as a gift that is beneficial
10		to the research corporation's business of research,
11		training of research personnel, and publication of
12		research findings;
13	(5)	To have a corporate seal;
14	(6)	To sue and be sued in its own name;
15	(7)	To serve as trustee or beneficiary under terms of any
16		gift, indenture, or will;
17	(8)	To apply for, take out, receive by purchase or gift,
18		hold, administer, and dispose of copyrights, patent
19		rights, licenses, assignments of inventions,
20		discoveries, processes, and other property[ $ au$ ] rights
21		or interests therein, and the income thereof,

1		absolutely or subject to [such] conditions or trusts
2		as may be attached thereto or be imposed thereon, and
3		to obligate itself to perform and execute any and all

- 17 Revised Statutes, by section 4 of this Act shall apply only to
- 18 contracts entered into by the research corporation of the

## Report Title:

RCUH; UH; Purpose; Powers; Exemptions; Contracts for Services

## Description:

Clarifies the purpose of the Research Corporation of the University of Hawaii and that its undertakings shall be limited to acts that are reasonably necessary to carry out its purpose. Repeals the requirement that the University of Hawaii contract with the Research Corporation when the University determines that other various agencies cannot more effectively or efficiently accomplish certain research and training activities. Grandfathers existing Research Corporation contracts and requires new contracts be subject to new limitations. Limits the scope of the special account the Research Corporation is authorized to establish. Requires revolving accounts to follow University of Hawaii Administrative Procedure 12.204. Limits internal service orders and revolving accounts of the Research Corporation that use University intramural funds to certain projects and requires biannual reports to the Legislature.
