A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Alzheimer's disease
- 2 is a large and growing epidemic significantly impacting Hawaii.
- 3 More than six million Americans currently live with Alzheimer's
- 4 disease, a figure expected to reach 12.7 million in 2050. In
- 5 2019, Alzheimer's disease was the sixth leading cause of death
- 6 in America, with deaths from the disease increasing one hundred
- 7 forty-five per cent between 2000 and 2019.
- 8 In 2021, caregivers of people with Alzheimer's disease or
- 9 other dementias provided approximately sixteen billion hours of
- 10 informal care at an economic value of approximately \$271.6
- 11 billion. More than thirty per cent of seniors in assisted
- 12 living facilities have Alzheimer's disease or other dementias,
- 13 and one-third of home health care and adult day care recipients
- 14 have Alzheimer's disease or other dementias. Average per-person
- 15 medicaid spending for seniors with Alzheimer's disease or other
- 16 dementias is twenty-two times greater than average per-person
- 17 medicaid spending across all seniors without dementia. By 2050,

- 1 spending on those with Alzheimer's disease will total almost
- 2 \$1,000,000,000,000.
- 3 The purpose of this Act is to appropriate funds for an
- 4 Alzheimer's disease and related dementias public health
- 5 campaign.
- 6 SECTION 2. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 8 thereof as may be necessary for fiscal year 2023-2024 and the
- 9 same sum or so much thereof as may be necessary for fiscal year
- 10 2024-2025 for an Alzheimer's disease and related dementias
- 11 public health campaign that educates the public on early signs
- 12 of cognitive impairment, the value of early detection and
- 13 diagnosis, and benefits of discussing changes in memory and
- 14 thinking with health care professionals, including the
- 15 establishment of one full-time equivalent (1.0 FTE) Alzheimer's
- 16 disease and related dementias services coordinator position
- 17 within the executive office on aging.
- 18 The sums appropriated shall be expended by the executive
- 19 office on aging for the purposes of this Act.

1 SECTION 3. This Act shall take effect on July 1, 2023.
