A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Alzheimer's disease 2 is a large and growing epidemic significantly impacting Hawaii. 3 More than six million Americans currently live with Alzheimer's 4 disease, a figure expected to reach 12.7 million in 2050. In 5 2019, Alzheimer's disease was the sixth leading cause of death 6 in America, with deaths from the disease increasing one hundred 7 forty-five per cent between 2000 and 2019.

8 In 2021, careqivers of people with Alzheimer's disease or 9 other dementias provided approximately sixteen billion hours of 10 informal care at an economic value of approximately \$271.6 11 billion. More than thirty per cent of seniors in assisted 12 living facilities have Alzheimer's disease or other dementias, 13 and one-third of home health care and adult day care recipients 14 have Alzheimer's disease or other dementias. Average per-person 15 medicaid spending for seniors with Alzheimer's disease or other 16 dementias is twenty-two times greater than average per-person 17 medicaid spending across all seniors without dementia. spending on those with Alzheimer's disease will total almost
 \$1,000,000,000.

3 The purpose of this Act is to appropriate funds for an
4 Alzheimer's disease and related dementias public health
5 campaign.

6 SECTION 2. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so 8 much thereof as may be necessary for fiscal year 2023-2024 and 9 the same sum or so much thereof as may be necessary for fiscal 10 year 2024-2025 for an Alzheimer's disease and related dementias 11 public health campaign that educates the public on early signs 12 of cognitive impairment, the value of early detection and 13 diagnosis, and benefits of discussing changes in memory and 14 thinking with health care professionals.

15 The sums appropriated shall be expended by the executive 16 office on aging for the purposes of this Act.

17 SECTION 3. This Act shall take effect on December 31,18 2050.
